2005 02 19 Saturday Timothy Good UFOs & Cover-ups

AB: "From the high desert – middle of the night – this is Coast to Coast AM.

I'm Art Bell.

Coming up in a moment, the world of UFOlogy and Timothy Good!"

* * *

TIMOTHY GOOD

AB: "Timothy Good has conducted worldwide research on the UFO phenomenon, including interviewing key witnesses and discussing the subject with astronauts, military and intelligence specialists, pilots, politicians, [and] scientists. Has lectured at universities, schools, at many organizations, and has even been invited for discussions at the Pentagon (!) in 1998 and at the headquarters of the French Air Force in 2002.

He has acted as consultant for several U.S. Congressional investigations. He was born in London – in fact, he's in London now.

Timothy Good gained a scholarship as a violinist to the Royal Academy of Music where he won prizes for solo, chamber, and orchestral playing. He played for fourteen (14) years with the London Symphony Orchestra!

He has also freelanced as a session player for television, dramas, commercials, feature films, and recordings with pop musicians – for example, Phil Collins, George Harrison, Elton John, Paul McCartney, and Rod Stewart ... and even U2.

So, my God (!), what a background for somebody into UFOlogy. Coming up in a moment, Timothy Good."

AB: "The Who's Who of UFOlogy, ah, definitely was visited by ABC television for this forthcoming documentary, um, and certainly the name Timothy Good is smack dab in the middle of all of that, so I suspect they probably reached out to you, Timothy, one way of the other. Did you speak to ABC?"

TG: "Yes, I spoke to one of the researchers, who just asked my, um, opinion and if I could put them in touch with, ah, certain, ah, key witnesses and things like that."

AB: "Yes."

TG: "And, um, I just think I helped them with one case actually, so that was the extent of my involvement."

AB: "Well, they spent two (2) days with me, Timothy. Two days here at my home (!)"

TG: "Great!"

AB: "It was pretty incredible!

Be about thirty (30) seconds probably on TV.

Anyway, ah, the really important thing here is that it is going to be a two (2)-hour 'Big Network" ABC prime-time documentary on UFOs. And the big question on everybody's mind, Timothy – even my mind: You never know what television is going to do.

Ah, it's being billed – you heard the ad for it run a minute ago – it's being billed as a serious in- ... investigative piece ..."

TG: "Right."

AB: "... on UFOlogy. Ah, any idea ... do you know how it's gonna come out? How they're gonna treat it? Do you have any sense?"

TG: "I know nothing other than their press release, Art, I'm afraid. But, ah, who knows?

If you recall, way back in the late 1980's, do you remember *UFO Cover-Up: Live*, which was, um, I think a two (2) hour production airing in Moscow and Washington simultaneously?"

AB: "Uh-huh."

TG: "And, um, there was quite a bit of, um, material forthcoming from some retired, ah, military guys, if you recall?"

AB: "Yes."

TG: "And we had the ... the, um, Condor and Falcon episode."

AB: "Oh, yes!"

TG: "And everything ... so who knows?

Um, I suspect however it'll be far more conventional than that. And a serious – for once – journalistic attempt to ... to get at the facts."

AB: "I hope you're correct (!)"

* * *

AB: "Um, how in the world did you first become interested in the world of UFOlogy?

It ... it doesn't seem from, you know, ah, the background of being a violinist and ..."

TG: "Hah!"

AB: "... it just doesn't mix somehow, yet it did."

TG: "Right. Well, I've always been passionate about aircraft and space travel, Art, so it was a natural progression – particularly when in 1955 (that's 50 years ago) I was given a book, *They Flying Saucers Are Real*, written by Major Donald Keyhoe, of course."

AB: "Umm-hmm."

TG: "And this was given to me by an American cousin, who said: 'Timothy, you know, you like, ah, airplanes and stuff, ah, it's time you learned about flying saucers.' So that is really where the interest was stimulated, and I haven't looked back since."

AB: "All right."

* * *

AB: "In America ... around the world, ah, we have had many very, *very* credible sightings, ah, by pilots."

TG: "Exactly."

AB: "How ... how many roughly?"

TG: "Ah, well, according to Dr. Dick Haynes ... Richard Haynes, who runs the, um, national, you know, the reporting center for ... for anomalous, um phenomena – NICAP – um, he thinks there's been about 3,400 and that might have increased by now, ah, since 1920."

AB: "That's a lot (!)"

TG: "It's a great deal, and I think there have probably been a great deal more, because many pilots do not report their sightings. Um, civilian pilots don't report them for ... for, ah, *fear* – it's ... it's a bad career move, particularly if they're in a major airline.

We found that out. And there are, in fact, regulation orders ... procedural orders that were published in America way back in the 1950's for the reporting of these things, and the press was to be avoided!

But, um, as far as the military is concerned, of course there are strict regulations and many, many encounters, um, are ... remain classified at an Above Top Secret level in the interest of national security. And I ... I can understand that, because as General Chidlaw said many years ago – and he was, um ... um, head of air defense command at one time: 'We've lost many men and planes trying to intercept these objects.'

And that is a fact!

And I think that's quite disturbing!

There have also been disturbing near collisions with airliners as well as military aircraft. And, ah, this would be disturbing if ... if ... if all the facts were known. But I think we ..."

- AB: "Well, Timothy, it's particularly disturbing in view of the fact that the United States government, ah, just simply dismisses UFOs, and I think they've said: 'They're not a threat to national security.' *And so they don't chase them!*"
- TG: "Well ... they do. And people say to me: 'You know, Tim, why if these things are so super-technologically advanced and they've got presumably very adequate means of protecting themselves why do we continue to ... to send jets up chasing them?

My answer to that is that we require as much data from these craft as possible. We need gun-camera film. We need radar signatures. We need communication signatures. We need ... we need all sorts of info. All sorts of things across the spectrum to ... to check and double-check against previous, ah, experiences.

Just how near we can get to these things. What the effects are. And we can learn a great deal more about their technology."

AB: "Well Timothy, you mentioned, ah, gun-cameras. It seems to me that, um, through all the years we should have gun-camera footage."

TG: "We do."

AB: "And we do have." (AB grins).

TG: "Yeah."

AB: "How much of ..."

TG: "We have a lot of it!"

AB: "Oh, we do?"

TG: "It's just ... most of it's been withheld (!)

I spoke to a ... um, a senior official in the Ministry of Defense, um, this is before Nick Pope by the way – one of Nick Pope's predecessors. Nick ... Nick headed the UFO desk at the ... the Ministry of Defense from 1991 to 1994.

Back, ah, you know, twenty (20) years prior to that, Ralph Noyes headed the same, ah, department, and he told me that part of his briefing was to be shown, ah, *military gun-camera clips of ... of UFOs. And he ... he saw them.*

He said they weren't absolutely sensational by any means, but, ah, these are things that, you know, have either been *lost ... conveniently* or destroyed or just ... just completely withheld in the interest of ... of security."

AB: "Well, Timothy, speaking of security, um, I'm in America where we still have the First Amendment. You're in Britain though where there ... there ... there's different kinds of laws with regard to disclosure of secret things."

TG: "Yes."

AB: "Isn't that right?"

TG: "Yes. Generally speaking, um, records are withheld. Um, certain military records – and others – are withheld, ah, typically for thirty (30) years, but often to fifty (50) or sometimes a hundred (100) years. And sometimes some things never get released at all."

AB: "Uh-huh."

TG: "A classic example is that, um, in the last few years we've had some Top Secret documents relating to Britain's ... the British government's Flying

Saucer Working Party – as it was called – which was established in 1950 under Prime Minister Clement Atlee. And those were only released in ... in 2002, 'cause they date back to, ah, you know, the early 1950's. In fact, they were ... they were released I think, um, 2001. And, um, they're still things being ... being withheld.

And ... we do now have a Freedom of Information Act. Now you'd had one for some ... what? ... thirty-five (35) years?"

AB: "A long time, yes."

TG: "I guess?

Well, this was ... this was passed by, ah, Act of Parliament and it's now in place as of January the 1st, 2005. And the Ministry of Defense anticipating that the cranky UFOlogists would be bombarding them with requests ..."

AB: (laughs).

TG: "... for all the UFO data ..."

AB: "They have a big bonfire, or what?"

TG: "... spent months if not years actually weeding out tons of stuff ..."

AB: "Well..."

TG: "... and dishing it out so that this would sort of pre-empt, ah, all the inquiries from ... from us guys."

AB: "Did it?"

TG: "And a lot of stuff has been released.

Ah, Nick Pope tells me that most of it's innocuous. But it has actually generated a tremendous amount of interest in the press, ah, more than any other aspect of the Freedom of Information Act.

And, um, just, um, last month there were huge articles, you know, in the Times, the Telegraph, the Financial Times, the Independent ... those are ... are, you know, main newspapers and some of the ... some of the, ah, smaller papers, ah, local papers. But, um, tremendous interest.

And there was a huge article by Nick [Pope] on the release of these things. And, um ... interestingly those who are determined still to debunk

everything, such as the ... the Times – they had, ah, an editorial. First of all, there was an article in the Times, which ignored all the really good reports by, you know, RAF [Royal Air Force] people, ah, the good reports ... impressive reports by pilots and, um, other military officers, which really ... ah, quite startling cases! It ignored those and concentrated on the lights in the sky and the balloons and the kites, and said: How Britain's X-Files Said That UFOs Were Just A Waste Of Time – that was the headline (!)

And the editorial actually said: 'Pie In The Sky: Flying Saucers Are Close Encounters With The Human Imagination.'"

AB: (chuckles).

TG: "Well I really, you know, that really got me going! And I fired off an email to the Times edi- ... editorial, but it was never published, of course."

AB: "Oh, really?"

TG: "Umm-hmm."

AB: "Um ..."

TG: "A lot of ... a lot of interest. And ... and in ... and in, as I say, in the UFO aspects of the Freedom of Information Act more than ... more than anything else."

* * *

AB: "Do you think the United States government and your government are hand-in-hand on the UFO thing?"

TG: "Up to ... up to a point, Art.

What I think happened is that since the late 1940's, the CIA [Central Intelligence Agency] came across to Britain and chatted with, ah, intelligence counterparts over here, um, Air Force people as well, and they ... they I think suggested that we play down the really good sightings."

AB: "Yes."

TG: "I'm sure of this, because the Flying Saucer Working Party seems to have had a remit to debunk ... especially the best sightings.

Like in 1950, um, in August 1950 there was a sighting – a low-level sighting at the Farnborough Air Base, where a lot of test pilots were based. And this thing came over at low level. An actual craft

accompanied by hissing and crackling sounds. It was seen by one of their top pilots ..."

AB: "Really?"

TG: "And other personnel. And the thing was repeated at a further distance in the following ... about three (3) weeks later – seen by *many test pilots!*

And those who were interviewed were told not to discuss it with anyone ... not even among themselves."

AB: "Hmm."

TG: "And the whole thing was debunked. And you can see that in ... in the reports, where they say: 'You know, the poor chap obviously, ah, he was just ... they were just seeing "conventional aircraft."

I mean, you know, and they were *absolutely outraged* when these reports came out a few years ago."

AB: "Well, that certainly sounds like the good of USA to me."

TG: "Yes!"

AB: "Ah ..."

TG: "Certainly ... in my opinion."

AB: "Why do you think, Timothy, that our mutual 'good friends', the French (AB grins), appear to be, ah, so much more open, ah – and they really do – about UFOlogy? Ah ... why?"

TG: "Well, (TG exhales) it's not that they don't have difficulties there. Believe me, they're ... they're ... I've spoken to ... to officials – military and otherwise there – and they ... they are very concerned about *ridicule*. Because you know, even in ... even in the French, um ... ah, Ministry of Defense there's ... there's some mixed views about the subject and there's a 'need to know', and all that sort of thing. So most people don't actually know what's going on, and they tend to ridicule those who take a serious interest in it.

But, um, they are more open – it's true! I mean, they ... they have this, ah, group – SEPRA (Service d'Expertise des Phenomenes de Rentree Atmospherique OR Atmospheric Re-Entry Phenomena Expertise Service) is the acronym, and, um, they still investigate cases. And ... but the real

work is still done behind the scenes as in ... as in other countries. Um, so it's not ... not as if it's a sort of 'total disclosure,' um, in France."

AB: "Um, if you were to look around at the various countries of the world, including Brazil, Japan ... I mean just all around the world, ah, South Africa – what country do you think is the most open about UFO incidents?"

TG: "Well, in recent years I would say, ah, Russia (!)"

AB: "Russia? (!)"

TG: "Yah. Because a great deal of stuff has come out there from, you know, high-ranking generals have come forward. They've appeared in several documentaries, including in ... in, um, the excellent *Out Of The Blue*, and, um, documentaries ... other documentaries that I've been involved with. And, ah, it's quite amazing some of these people have come forward.

And, ah, Gorbachev, as you know, has come out with several statements acknowledging that he discussed the extraterrestrial threat with President Reagan at ... Geneva in 1985."

AB: "Ah, as a theoretical question or ... or something beyond theory?"

TG: (laughs). "I wish I knew!"

AB: (laughs).

TG: "Because, you know, he ... he didn't exactly pass it off.

He said: 'You know, the United States President and I, um, discussed the question of an extraterrestrial threat and agreed that, ah, in the event of an invasion, the Soviet Union and the United States would join forces to repel such an invasion.' And he ... he went on to add: 'You know, I don't dispute the hypothesis, but I think it's too early yet to worry about, ah, such a possibility."

AB: "But you believe we had an agreement with the then Soviets to, ah, join forces in the case of an invasion?"

TG: "I think it's likely."

AB: "Wow! That's pretty interesting!

I ... I know that, ah, President Reagan of course made several statements alluding ... alluding to the possibility that there could be others. There could even be a mutual threat (!)

I recall his saying that and the shock it brought on when he did."

TG: "Yes. Well, of course his interest goes back to 1974 if not earlier, when he was Governor of California. Because he ... ah, there was a UFO sighting while he was flying in the Governor's plane, and he ordered the pilot to chase it. Of course, they ... they, you know, they couldn't get anywhere near it, but it created a lot of excitement.

And there's actually a Wall Street journalist on board the plane and Reagan was all excited – because I think he'd had a previous sighting – and he ... he talked about his ... his great interest in the subject and so forth.

And I think in that, ah, very important speech before the United Nations General Assembly in 1987, I think it was September 1987, he says: 'You know, I occasionally think how quickly our differences worldwide would vanish if we were facing an alien threat. And yet I ask: 'Is not an alien force among us?'

And then he went on quickly to add: 'You know, what could be more alien and, you know, that war and the threat of nuclear war' and so on."

AB: "Umm-hmm."

TG: "But I think he was trying to tell us something. I'm absolutely convinced of it."

AB: "Do you believe that a U.S. President or even British Prime Minister can take office and on their first day, ah, tell their aide: 'Look, um, here I am. I want everything on my desk that we know about UFOs. And I want it there in the morning.'

Can they ..."

TG: "Ha! They can try.

President Clinton tried. He didn't get anywhere fast ... that's for sure!

So ..."

AB: "Do ... do you really know that?

I mean, maybe he did find out everything and maybe that everything included, um, you know, not informing the American people for the following reasons (!)"

TG: "That may be the case, Art, I ... I honestly don't know.

I suspect he was not told everything."

AB: "Well, last Sunday we repeated a program I did with John Lear, who took me through what's called 'Lear test'"

TG: "Umm-hmm."

AB: "Ah, he ... he ... he went through this long litany of: 'Listen here, Art, here are the things:

Ah, could you tell the public the following:

And he named off about twenty-five (25) things that obviously you could never, ever tell the American public ..."

TG: "Right!"

AB: "... and have a shred of credibility left."

TG: "That's absolutely true! I ... I ... I wholeheartedly agree!

I don't know *all the reasons* for the cover-up, Art, but I ... I suspect that some of the reasons would be disturbing to the body politic, as it has often been said, and to society in general. It's much better just to ... to let the facts leak out gradually."

AB: "Huh.

All right, Timothy, hold on. We're at the bottom of the hour.

My guest from London, England is Timothy Good.

On a Saturday night – Sunday morning for some of you – this is Coast to Coast AM doing what it does best ... in the darkness."

AB: "Good Morning, everybody!

Well, we are, you know, being visited – you don't really question that, do you? They are up there! I know ... I had one right above my head (!)

Kinda hard to deny when that happens to you.

Be right back!"

* * *

AB: "Sure is interesting!

Timothy Good just suggested that it's a trickle-down sort of slow release policy regarding this information that absolutely couldn't be released *en masse* – it just couldn't!

It would upset the ... the ... you know, the whole world would go on tilt!

Ah, and so I've wondered a little bit over the years – and I've been doing this for a lotta years now folks – whether I could actually be part of that process ... an unwitting dupe ... as it were, ah, trickling out information that the government wants trickled out?

Of course, that would make many other people, including, ah, the ABC television network part of that process.

Timothy, have you ever wondered if you were part of that process?"

TG: "Oh yes, indeed!"

AB: "You know, being used? Yah?"

TG: "In ... in fact, um, I have.

The last chapter of my last book – and I'm going to send you my last book – *Unearthly Disclosure*. Art, I don't know if you have it, but I'd ... I'd ..."

AB: "I do not, but I would love it!"

TG: "Okay."

AB: "And moreover, if you could sign it, I would love ...?"

TG: "Oh, absolutely!"

AB: "All right."

TG: "In the last chapter, ah, which is entitled 'Resident Aliens', I disclose, ah, information which has come to me via a high-ranking source, who worked at the Pentagon in the U.S. Air Force air staff and joint staff."

AB: "Uh-huh."

TG: "And, um, this information was given to a friend of mine, um, an ex-army intelligence guy, who's, ah, a journalist in the aerospace world.

Between 1986 and 1989 he was given a great deal of information about what was actually going on. And I'm quite sure this was part of an official leak."

AB: "How much of that ..."

TG: "Officially sanctioned."

AB: "... you, how much of that can you relate here?"

TG: "Oh, there's ... there's tons of it!

I mean, what do you want to know about? Bases? I mean, I've been told, for example, aliens have been coming to Earth for a very long time. They've established permanent bases here in Australia, the Caribbean, Pacific Ocean, Soviet Union, and in the United States. ... Specific locations are given in some cases.

Now, that's just for starters, but, um, obviously there ... there is an amount of disinformation. And the question is: 'How does one sort the wheat from the ... from the chaff?'"

AB: "How do you?"

TG: "There's a great deal of in- ... information. We've apparently, ah ... some military and scientific elements in the intelligence community have established communication with ETs. There has been a transfer of their technology – we are working on it.

Um ..."

AB: "Well let's be clear on this, Timothy. I asked you the question about the President for a reason.

You know, whether he could demand everything that we know about UFOs and get it! (?)

Of course, we can't know the answer to that, but I guess the bigger question is: Timothy, ah, is it your opinion that there is a group outside of elected government ... government's knowledge that, ah ..."

TG: "Absolutely. ... Absolutely."

AB: "... sort of a 'Majestic Twelve (12)' or ... or its equivalent?"

TG: "Or ... or its equivalent.

But of course, what I was told that, ah, for example, a hundred (100) ... at least a hundred (100) people in the ... in OSI, which is the U.S. Air Force intelligence ... Office of Special investigations. Ah, there are at least a hundred people – I'm going back again to 1986 ... 1989, 'cause that's when this information was, ah, given.

There are at least a hundred people in OSI, who had knowledge in varying degrees about the extraterrestrial presence and were actually *dealing* with this."

AB: "Huh."

TG: "When I was in the Pentagon in 1998 at the invitation of General Kenneth Israel, who was the then director of the Defense Airborne Reconaissance Office – as it was then called. They ... they at that time handled the unmanned spy planes – the UAV ... Unmanned Aerial Vehicles."

AB: "Right."

TG: "Um, he indicated to me that in his opinion this was ... this was more a *policing* task as opposed to national security. And he therefore suggested to me or hinted that OSI was much more likely to be in charge of ... of the investigations."

AB: "Oh, a policing task?"

TG: "That's ... that was his opinion."

AB: "As in?"

TG: "Make of that what you will."

AB: "As in 'cleaning up'? As in, you know, sanitizing some incident?"

TG: "Well, OSI, um, has all sorts of, ah ... ah, tasks, you know? Other ... other than some of the more obvious ones."

AB: "Yes."

TG: "I mean, they're into counterintelligence. They're into investigations.

They're into ... into, um, problems with, ah, people violating their national security oath and things like that.

So, ah. I think it's interesting from that point of view. But ... but, um, I ... I ... I was given a great deal of information, really, and you'll learn that in ... in that last chapter.

And, um, there are concerns about, ah, what the aliens are doing – it's not a question I'm told of one species coming here. *There are several.* And more important, *there appears to be a conflict of interest between ...* between some of these, ah, beings."

AB: "All right."

TG: "Regarding ... regarding our planet (!)"

AB: "All right."

* * *

AB: "Um, can you describe, ah, the various motivations of these groups? Ah, if you ... if you understand there are conflicts, then that would imply we understand something of the motivations."

TG: "Well, I can only speak, ah, very broadly here, Art.

Um, there's ... there's ... there's *definitely* several races. I mean, goodness knows, I ... I wouldn't put a number on it, you know, as to who's been coming here and for what purpose over the years, 'cause it's been going on for thousands of years.

But I ... from what I ... I gather, some of them definitely have a vested interest in this planet – and its resources (!) – and, ah, there is concern about the abduction process, which, ah, it is believed by them that is it definitely related to some sort of hybridization program (!)"

AB: "Ah, Timothy ..."

TG: "Now ... sorry, go ahead."

AB: "I'm sorry. Are the resources of this planet, um, oil and metals, and that sort of thing or are they ..."

TG: (clears his throat).

AB: "I ... I think more likely the, ah, the human occupants of Earth?"

TG: "I ... I think more likely the human occupants (!)

They appear to me to need, um, animal materials as well – some of them. Um, I do think there's ... could ... could be an interest in some of our ... our materials and minerals here.

Some of them have suggested that some people, who ... who've established communication with humans, have established that they ... that they need stuff here."

AB: "Hmpf."

TG: "And, um, there appear to be a number of very large undersea bases which are causing disturbances.

Now, um, as it was put to me, you know, there's a distur- ... they're concerned of the fact that some of the aliens are 'messing around with tectonic plates in the Pacific Ocean.' Now that opens, ah, all sorts of 'cans of worms.' I think recent events, ..."

AB: "Yes."

TG: "... um, might suggest.

I'm not suggesting for one moment that the tsunami had anything to do with aliens. But I'm just saying that apparently, according to this source, some aliens are messing around with the tectonic plates and they had some large undersea bases.

Now, why are they doing that? I don't know."

AB: "Yes, Timothy, but a natural inference from that statement would be that there could be a connection between the tsunami and messing around with, ah, Pacific tectonic plates (!)"

TG: "There could be. There could be. Other ... or they might even be messing around with the tectonic plates for their own purposes to protect their bases or to protect the Earth.

You know, that's ... that's the good news! I mean, there's always good news and bad news. It's like, ah, you know, whatever threat is posed by aliens, we have to look at ... at the positive, ah, side of things. The fact they've shown their ability to paralyze our nuclear missile bases ..."

AB: "Well, you ..."

TG: "... at ... at the drop of a hat."

AB: "They have shown that too, haven't they?"

TG: "Yes."

AB: "Ah, would you please explain to the audience a couple inci- ... incidents where that occurred?

This is pretty heavy stuff, folks ... it's undeniable!

I've seen specials on television about what you're about to hear about and, ah, it seems undeniable.

Timothy, how good is the evidence that this really happened, and what happened and when?"

TG: "Well, there've been numerous witnesses who've come forward, um, Robert Salas for one.

I ... I haven't got the book [at] hand. I've just received a new book by Robert Salas and ... and another author about those extraordinary events which is ... which is very impressive. And during the next break, I'll ... I'll ... I'll go and get it because I would, ah, you know, I really want to ... to plug that book (!), because I'm most impressed by it ... by what I've read about ..."

- AB: "But the bottomline is, ah, if I recall correctly, the U.S. had a couple of missile, ah, launch ..."
- TG: "They had intrusions!

There've been numerous intrusions, um, at nuclear missile sites in ... in North Dakota ... all ... all ... all over."

- AB: "Actually they were disabled I believe."
- TG: "They were disabled! Yes, and it's happened in the Soviet Union too ... in the former Soviet Union."
- AB: "And I ... I'm recalling this TV special in which some, ah, ICBMs [Inter-Continental Ballistic Missiles] in Russia actually went into a launch sequence (!)

Is that true?"

TG: "I vaguely recall ... I vaguely recall that, Art, but I can't, ah, I can't confirm that."

AB: "Okay."

* * *

AB: "Um, did the U.S. military capture an alien spacecraft before Roswell?"

TG: "Well, you know, um, last year – and ... and continuing now – I've been investigating an extraordinary case, reported ... goes back to August of 1945, when in San Antonio – not Texas – San Antonio, New Mexico, which is not that far from the White Sands, ah, missile range."

AB: "Right."

TG: "Um, two (2) boys, um, encountered an apparent crashed craft and on their ... on one of the boy's father's ranches. Jose Padilla was the ... was one (1) of the boys, and it was his father's ranch. And the other witness was, ah, Remigio Baca ... Remi Baca.

And I went out to meet them in June – at least I met Remi; I have not met, ah, Jose yet, but we've been in ... in communication.

Um, it's an extraordinary story (!) Ah, they were quite alarmed by the incident. They claimed to have seen a ... a large area where there was ... there was ... can- ... in this canyon where this craft had come down and a gouge in the earth, ah, the size ... as long as a football field. It was vaguely circular, ah, with a sort of type of fin on top, but nothing like an aircraft fin.

They've made a model of it. I've seen it. And um, they headed back, worried about casualties and so forth. Because they ... they actually ... there was ... they'd seen when they got as close as they did at some sort of strange-looking creatures moving around inside it – *like children!*"

AB: "Huh."

TG: "And, ah, they [the creatures] had no hair on.

They [the boys] couldn't see much more detail than that. And they went back and told, um, Padilla, Senior (Sr.), who told the police, and they all drove, ah, toward the crash site two (2) days later, but the wreckage was nowhere to be seen.

But suddenly, ah, it reappeared (!) (?)

It had been ... apparently someone had made an attempt to cover it up with dirt and debris (!)

And then, ah, later on, the craft – I'm cutting a long story short here – the craft was apparently recovered. And the boys – at ... at several stages – got a chance to witness those things from a ... from a hidden area, and this thing was ... was loaded onto a 'tall-boy' [trailer truck].

And, um, as I say they were watching from this secluded position and, ah, soldiers were throwing bits down a crevice, so they didn't ... wouldn't have to carry them all the way down."

AB: "Huh."

TG: "It rings true (!) in a way.

Um ... a lot of information forthcoming –

One of the boys ... the older boy, Jose Padilla, at one stage, um, when the craft was unguarded, ah, clambered inside, um, a gouge in the ... in the opening on a sort of, um, area there he managed to extract a device.

Now, I have seen the device and handled it, and photographed it ..."

AB: "Really?"

TG: "Um, the ... the unfortunate thing is – and it's as I refer to ... it's the fly in the ointment – is that it does look very, very conventional (!) It looks like some kind of bracket with some provisions for fasteners or screws or whatever. It's about eleven inches (11 in.) long.

Um, it has been analyzed and it is ... it does appear to be conventional aluminum (!)

So that ... that ... that ... that's a problem – but on the other hand, um, you know, we have ... we have the testimony of ... of these two (2) witnesses, and they're absolutely adamant that this thing ... this thing did event [sic]. So there is this ... this contradiction, which ... which I'm left with, and, um, it is a stumbling block for me I have to say."

AB: "What about Roswell itself, Timothy?"

TG: "Ah, Roswell happened!"

AB: "It ... it happened? I mean you just ..."

TG: "Roswell happened, yes."

AB: "... just straight out it really happened?"

TG: "I mean all the testimony, sworn affidavits from all these high-ranking people. You know, we ... we have DuBose, who's often ... often overlooked. Um, General DuBose, who said that the ... that the cover-up was ordered by General Clements McMullen at the time. And there are very, very good reasons.

They said: 'Look, you know, we've just been through a World War with, ah, atomic bombs on Japan, firebombing of great cities, destruction on an unprecedented, worldwide scale.

Then came this flying saucer business. And it was simply too much for the public to have to deal with. And ..."

AB: "Was Roswell, ah, 'the beginning'? And sometime between Roswell and now, when did our governments, respectively, ah, recognize, meet, even make deals with some of these creatures? And did that in fact happen?

I'm sure you believe it did."

TG: "I think it did happen. Yeah, I don't know about a deal, um, but I think we ... we certainly there was an exchange of information. There was a survivor by all accounts (!) – I'm not the only person to, um ... Dr. Ed- ... Dr. Edgar Mitchell, sixth (6th) man to walk on the Moon has ... has, ah, also established very good contacts in the military and intelligence communities, and he's also been told that there was, ah, a survivor, who lasted a certain number of years. And I ... I believe that (!)"

AB: "Ah ..."

TG: "And I think ... I think official interest began well before Roswell. Certainly during World War 2, because all these pilots were reporting these things."

AB: "Do you ... do you ..."

TG: "Not just 'foofighters'."

AB: "So ... do you think there's been 'official contact'?

Ah, when I ... when I say that I mean I guess more than just with a crash victim. For example, ah, has there been some sort of communication between species?"

TG: "I think so. Um, I'm bearing in mind the story about President Eisenhower in 1954, ah, at what was then Muroc – later Edwards Air Force Base. Um, I ... I think there could be some truth to that story.

And I know from people I've talked to. People say, you know: 'Why don't they contact our governments' leaders, our military leaders?' Well, I think ... I think they have done [so]. But those ... but those are the people least likely to come out with the truth ..." (TG has a coughing fit).

AB: "Well, when you look at, ah, ..."

TG: "Excuse me."

AB: "That's quite all right.

Ah, when you look at the Earth, ah, and you talk about *minerals* or you talk about, ah, you know, what's here that's not on Mars and Venus, and, ah, all the other planets we're now discovering, ah, with Hubble and other telescopes. All these planets and all of these suns, but the unusual thing about Earth that really stands out would be US!"

TG: "Sure. I mean, I think Earth is unique! Not just in our Solar System, but maybe for light years around."

AB: "More than the iron! More than the uranium! Ah, it would be, ah, it would be the intelligent life on Earth.

It seems to me that would stand out like a beacon!"

TG: "Umm-hmm. Sure."

AB: "And that would account for their interest. That would be my guess anyway. Ah ..."

TG: "The interest was definitely accelerated in World War 2, because of our nuclear developments. That's for sure."

AB: "Well, I wonder what the current state of understanding, ah, between ourselves and, ah, whoever else it might be, is? Do you have clues about that?"

TG: "No – I wish I did! I'm trying!"

AB: "Do you have guesses about it?"

TG: "It would just be pure speculation, Art. I prefer to deal with, ah, what ... what few facts we can be sure of."

AB: "Okay. Well I know that, you know, there is a lot of conversations you had with people that probably ... information comes to you that you wouldn't put on the air."

TG: "Yes."

AB: "And ... and from that I thought you might have some 'educated guesses."

TG: "Yes, but before I exploded with my coughing fit, I was about to tell you of ... of Air Marshal Sir Peter Horsley, who was an air [unintelligible], like a kind of military attache to the Queen and Prince Philip for seven (7) years, back in 1954. And he was also Deputy Chief of Strike Command and a decorated war hero, flown ninety (90) different types of aircraft.

And he claims that in 1954 he had a two (2) hour meeting with an extraterrestrial being arranged via a British Army General. And this took place in the middle of London in the presence of a witness.

And he wrote up that story in his autobiography, *Sounds From Another Room*, and he gave me additional ... some additional information, which I published in ... in my book, *Alien Base*.

And, ah, it's absolutely extraordinary! And, um ..."

AB: "Can you, ah, tell us about ..."

TG: "There's ... there's so much information attached to that story. I mean, this ... this, ah, being appeared human-like. He didn't say: 'I'm an alien.' He could ... first disturbing thing that ..."

AB: "Tell you what, Timothy: It's top of the hour. Hold tight."

TG: "Okay."

AB: "When we come back, we'll have a full hour.

Good thing about long form talk radio – you can get into some of these things ... and we will!"

* * *

AB: "Oh yes, when it comes to a ... the details of a two (2) hour meeting with an alien being, then I have time ... we all have time for some of the ... the good details of that. Ah, coming right up!"

AB: "Timothy, welcome back.

A two (2) hour meeting ... if there was a two (2) hour meeting, ah, I would like to know the details of that meeting. I would like to know as much as I could what was said and what was answered. And whatever you can tell me."

TG: "Well, the first thing that Sir Peter noticed during this meeting was that this quy – whoever he was – was able to read his mind!

And later on, Sir Peter told me – he didn't write about this in his book – but he told me that what disturbed him more than anything else was the fact that this guy knows all Britain's Top Secret nuclear secrets (!)"

AB: "Huh."

TG: "And ... well he began by explaining that, ah, Man was now striving to sort of break his Earthly bonds and travel to the Moon and Planets beyond. We were developing ... but there was a Dark Age on Earth.

Ah, we were prepared to sacrifice almost anything: the natural environment, animals, and humans. And there was a dreadful spectre of ... of, ah, blowing up our World. So they were *concerned* it seems about that.

He went on to the origins of life in the Universe. Stated that most of the UFOs we see are robot-controlled."

AB: "Uh-huh."

TG: "Some are manned in order to oversee the whole program and to ensure that the probes do not land or crash by accident.

And, um, they spoke that there have been, um, since Time Immemorial observers of our planet ... vessels out of the sky bringing strange visitors.

And that contact has been established on a very selective basis, um, where they judge that such contact could not harm either party."

AB: "Hmm."

TG: "And apparently the ... they say they've studied us for a very long time. They have extraordinary technological abilities. Very highly developed mental powers, including extrasensory, thought-reading, hypnosis

And this I find particularly interesting – the ability to use different dimensions (!)"

AB: "Hmm. As ... as a matter of fact, I ... I was going to ask you, ah, somewhere down the line that, um, you know, beings coming light years and light years away seems incredible. Maybe it can be done, but it seems incredible. But if ... if we just, you know, if we had someone come from another dimension, they would appear to us to be as alien as if they had come from another planet.

And of course, you know, you['re] just hop, skip, and a jump from a- ... another dimension if you know how to do it, so ..."

TG: "Well, the implication in this case is that these beings are related ... some of them at any rate ... are related to us genetically."

AB: "Huh!"

TG: "And what I've heard from other sources is that, ah, some of these highly advanced beings are indeed, um, responsible for upgrading humanity. Upgrading the development of human beings going way back tens of thousands of years.

Um, as to the dimensional aspects, I don't doubt that there are beings, who exist solely in other dimensions, but the implication here is ... is that this guy was quite physical, quite solid, but ... but that the races are so advanced that they can *manipulate* dimensions ... and I think this happens with their spacecraft (!)

There's a number of in- ... intriguing accounts by people claiming contact to say that it is a question not just of linear travel – I'm sure you've heard all this before ... all you listeners and ... and you of course, Art – that they manipulate space-time as Einstein called it ..."

AB: "Umm-hmm."

TG: "... by folding it rather than traveling ... traveling in a linear mode."

AB: "Umm-hmm."

TG: "So that ... to manipulate space-time is to manipulate a dimension (!)

And I think this would account for their extraordinarily rapid disappearances sometime. Um, sometimes maybe they're just going so fast in the blink of an eye.

But I think at other times they're just translating into another dimension to ... to get where they want to in, ah, you know, in maybe split seconds ... who knows?"

* * *

AB: "Let's jump back to something you said.

You said, ah, that we're some ... we had some relationship to them genetically (!) Boy, that sure is one sentence that covers a lot of territory, Timothy, ah ..."

- TG: "Yes. Well of course, this has been mentioned by ... by a number of researchers going ... going way back and ..."
- AB: "Yes, ah, well, are they our Creators?"
- TG: "Well, what I understand is that they genetically upgraded the existing beings on this planet. The basic ... basic, um, humans that ... that ... when they first appeared. The basic creatures."
- AB: "So there was already life existent on Earth when they arrived, and they did ..."
- TG: "Apparently."
- AB: "... they did the upgrades."
- TG: "Yeah ... yes. I mean, we were ... we were, you know, just vaguely out of ... out of the ape stage. And, ah, so it is said! So it is said by a lot of contactees.

I have a lot of reports of this in ... in *Alien Base*, my book which specializes in contact stories. And there's a marvelous [one] by ... by Albert Coe, who encountered an alien being and his spacecraft in Canada in 1920. And he had meetings throughout his life with this person. And, ah, with ... with one or more of these people. *And I find that story very compelling (!)*"

AB: "But that does ... that does make them our Creators though!

If they 'upgraded us' ..."

- TG: "Yes."
- AB: "... interesting phrase ..."

TG: "Yes."

AB: "... -- ah, then they took us from what was not intelligent life and did the upgrade that made us who we are ... making them our Creators!"

TG: "I think to that extent you're ... you're right. Yes.

And I think that this is sort of a colonization process, if you like. I think we were colonized."

AB: "Huh!

Um, and ... and these kinds of stories ... have ... have led you to this position?"

TG: "Yes, absolutely.

Um, one of the most compelling contacts [was] with a lady I know for many, many ... several decades, in fact. She's ah, passed on unfortunately, but, ah, she had contact back in 1963 with several, um, human-type extraterrestrials, who were engaged in a very delicate operation which involved the use of, ah, some of our top scientists. Um, some of whom actually traveled to their bases (!) And they had bases ... some of these people, for example, in ... in South America."

AB: "We've heard of a lot of recent incidents ..."

TG: "Yes."

AB: "... in South America, of course."

TG: "Yeah."

AB: "Um, you've looked into those?"

TG: "Yes, I have. I think ... I think there are, ah, probably a number of ... of alien bases in ... in South America and offshore (!)

There's an extraordinary case of the guy, ah, Ludwig Pallmann, a German businessman, um, who in the late sixties (1960s), ah, encountered a group of these beings and actually visited their base, which was in the jungle, um, in the Amazon area. Extraordinary story!"

AB: "Well, you ... you would think that, um, the United States and Russia with all these spy satellites, um ..."

- TG: "Yeah."
- AB: "... would be clearly onto an alien base."
- TG: "Yes, it ... well, it depends on what ... what the counter- ... the counterintelligence is of the aliens in terms of disguising, ah, their technologies and their bases. So, I'm sure they're capable of ... of dealing ... dealing with that, but yes, I'm quite sure, ah, in fact, I'm a hundred percent (100%) sure that some governments do actually ... actively use their spy satellites for trying to detect undersea and, um, other activities on this planet."
- AB: "Yes, interestingly ... Big Project, um, called HAARP, ah, the HAARP Project in Alaska. Ah, one of the stated goals of HAARP is underground tunnels and bunkers. They're looking for them with this wild project up in Alaska. Heard about that?"
- TG: "I've heard about it, but I'm not ... I haven't gone into that in sufficient degree to be able to comment."
- AB: "Might be worth looking into on ... on your part, because, ah ... ah, underground tunnels and tunnels ..."
- TG: "Yes."
- AB: "... that's very much part of what their original charge is."
- TG: "Yes, Richard Sauder I believe has done a great deal of work on ... on that, if I'm ... if I'm correct."
- AB: "Um ... some of them then, um, you know, this ... this does beg questions about, um, all these religions that Man has on Earth, ah, and these concepts of a ..."
- TG: "Right."
- AB: "... Creator, ah ..."
- TG: "Yes."
- AB: "... leading you down that path, ah"
- TG: "Yes! Umm-hmm. Well, I think it's unde- ... undeniable. I mean, you've only got to look at ... at the Bible.

I mean, there are reports apparently in the Hindu Vedas and the Brahman records that the Bible is ... is absolutely chock full of extraordinary, ah, incidences of strange beings, ah, who mated with, um ..."

AB: "Yes, it is!"

TG: "... Earth people ..."

AB: "Yes ... yes."

TG: "... who produced people who lived for many hundreds of years apparently (!), if you believe it – I wasn't there! I don't know."

AB: "That's all true (!)"

TG: "Um, and then, you know, the Ezekiel, ah, Elijah and the flying chariot? All these things, um ... um, descriptions of strange beings.

And then the New Testament: I mean, Jesus, the Star of Bethlehem, and whatever that was – it wasn't a star! It was very specific. *It pointed out a particular building!*

You have Jesus' phenomenal abilities: tele- ... telepathy ... telepathy, levitation, healing. Um, and the ... the Resurrection, which, ah, even the Catholic Church I believe acknowledges to be, ah, a bodily ... a physical resurrection accompanied by shining beings and then the reappearance to Paul on the road to Damascus. You remember that story? The dazzling light!"

AB: "Oh, yes ... of course!"

TG: "Blinded the soldiers – they couldn't hear anything, but ... but, ah, Jesus spoke out of this blinding light in the sky and so forth.

And I think the Angel Gabriel might well have been ... maybe something to do with *art- artificial insemination* – what might explain the ... the so-called 'Immaculate Conception.'"

AB: "Well, ah, it has to be said that, um, so many of the modern sightings and close contact sightings seem to involve reproduction ... repro- ... a study of reproduction ..."

TG: "Yes."

AB: "... ah, reproductive organs."

TG: "Yes."

AB: "Um, when you get stories from people who have been abducted, set frequent- ... very frequently ... I ... I ... you know, I ... I was really surprised, Timothy, at the amount of sexual content in abduction stories when you really get down to brass tacks ..."

TG: "Yes."

AB: "... with abductees."

TG: "Yes!"

AB: "It is remarkable!"

TG: "Definitely."

AB: "Any ... any guesses about what they're trying to do?"

TG: "Well, I think hybridization is the name of the game (!)

The question is: Is it for their benefit or ours?

They often say ... abductees say: 'Oh, you know, they were lovely beings. They said: 'Oh, it's all just for us,' you know? But I don't ... I don't ..."

AB: "ALL THE TIME! ALL THE TIME. TIMOTHY!"

TG: "I think it's for their benefit more likely.

I spoke to an abductee in ... in Puerto Rico. Puerto Rico's a country I visited on ... on seven (7) occasions. And, ah, I met a contactee there, who claims to have been taken to an *alien base within Puerto Rico* (!)"

AB: "Umm-hmm."

TG: "And, um, he saw many different types of craft in this **giant cavern** within the mountains. And they said, you know: 'Nothing to be afraid of.' Um, you know: 'We're ... this is something ... we want to help you out.'

And ..."

AB: "Umm-hmm!"

TG: "... and so forth.

And, um, they mentioned I believe the hybridization. And I asked this abductee what he thought the time purpose of this hybridization process was, and he ... he was convinced it was for their own benefit to help them to adapt to this planet."

AB: "Well, I've interviewed many, many abductees and the *vast* majority of them, Timothy, say that these are, ah, these are our friends (!) These are beneficial beings, who want nothing but the very **best** for us!

And their treatment while being abducted [kidnapped!] was absolutely superb. Not a bad word to say (!) ..."

TG: "Umm-hmm."

AB: "... about them, Timothy. Ah, but to put it crudely: 'Their minds have been screwed with.'

So ..."

TG: "I think so. I think so."

AB: "... so you know, there are a very few researchers in the United States – I don't know about Great Britain, but you sound like you might be one of them – who aren't so absolutely sure these are 'warm, fuzzy creatures' with our best interests in mind."

TG: "Quite right!"

AB: "Yes ... that would be you then?"

TG: "Yep."

AB: "Ah, so if they don't have our best interests in mind, ah, what do you think their a- ..."

TG: "Agenda?"

AB: "... agenda ... ? Yes."

TG: "I don't know, Art. (pause) Honestly."

AB: "Yeah, well, that's of course ... all the big questions, ah, just sort of almost can't be answered. The who, the what, the where, the when. Ah ..."

TG: "Right."

AB: "... almost none of this can be answered.

Now it'll be interesting to see what sort of conclusion a large network investigation like ABC's will come up with."

TG: "I can't wait!"

AB: "I've got little hints that they may be suggesting at the end of it all – ah, and this is just guesstimates from the internet, folks – that, ah, there needs to be a *more serious investigation* in all of this."

TG: "Yes."

AB: "That it ... it simply has been laughed at too much and there's some serious stuff at question here ... at issue."

TG: "Yes!"

AB: "So ..."

TG: "Well, if that's all they do, at the very least that ... that is ... that is a great step forward."

* * *

AB: "And I suppose ... one could ... the intense interest in UFOs and the many sightings, ah, may go back into the 1920s or even go back I'm sure to Biblical times. However, the real flap started and has never let up since, ah, what? Since Roswell? (!)

Well, gee whiz!"

TG: "Even before Roswell."

AB: "Since the atomic bomb!"

TG: "Yes."

AB: "The atomic bomb ... the atomic bomb.

Now that must have been a real marker in time and space when we lit one off! Wouldn't ya think?"

TG: "Yep, I would think so. Definitely! Absolutely definitely.

And it ... it would also explain the concentration of sightings in the New Mexico area as ... as, you know, all ... all the testimony from ... from the

military and scientific people, who were summoned urgently to meetings in ... in the 1940s, you know, about all these strange objects, ah, hovering over our rocket sights and nuclear sights."

AB: "Well, that ..."

TG: "They continue to do that by the way."

AB: "That began the age when we had the ability to destroy ourselves (!)

To utterly destroy the capability of life ..."

TG: "Yes."

AB: "... continuing on this planet. That's what began then."

TG: "Yeah."

AB: "So, um, any alien race monitoring us in any way would have at that moment taken notice.

Do you think that's happened?"

TG: "Yes! Definitely.

I'm not saying it's the only reason, but that's the reason for the acceleration of activity since World War 2."

AB: "In everything that you've heard, ah, Timothy, ah, about these meetings, ah, with the others, how convinced do they seem to be that we're going to blow ourselves up?"

TG: "Umm-hmm. Well, I'd always like to keep positive about that, but ... and I like to think that they might prevent us doing so specif- ... particularly if they have a vested interest in ... in their own security and our nuclear weapons. Because it's often been said and it was certainly said a lot in the ... the late 40s and 50s and 60s with, ah, contactees I have met. They were told [that] we ... we really don't know quite what we're doing, um, and that the effects of these, ah, explosions, ah, continue in- ... into the Solar System. And they don't just affect the Earth by any means."

AB: "Oh, really! Ahh ..."

TG: "Apparently. I don't know that's ... that's what ... that's what they ... they've said anyway."

AB: "I wonder if perhaps they affect other dimensions as well, and nuclear detonations could be ..."

TG: "Well, exactly – that's another ... that's another possibility that, um, I've considered."

AB: "Okay. My guest is Timothy Good. Stay right there, Timothy. Bottom of the hour.

Timothy Good wrote *Above Top Secret* and so many other books ... ah, *so many other books* that by now you must've heard his name. Certainly if you're into UFOlogy you know Timothy Good. If not, keep listening and we'll expand as we go along.

From the high desert in the middle of the night, this is Coast to Coast AM. Rockin' the night away with information ya just won't get anywhere else!"

* * *

AB: "You ever wonder about this?

I wonder if we were the first. You ever wonder if we were the first? Maybe there were other technological civilizations? I mean, think about it. If our civilization was utterly destroyed today, how many millions or even billions years would have to pass before there wouldn't be any trace of us left at all?"

* * *

AB: "My guest is Timothy Good, all the way by the way from Great Britain. So when we do get to the telephone stage of this, I want to remind the audience that even though we've got a superlatively good connection with Great Britain, there is a time differential, ah, of a fraction of a second or better where there's ... you can sort of talk on top of each other if you're not very careful. So what I would ask – and I know a lot of you are going to have questions for Timothy – what I would ask is that you formulate your question and sort of get it out, and then allow him to answer, so that we don't get into a situation where we're all interrupting each other. That's a necessity of the, ah, transatlantic connection.

Timothy, welcome back."

TG: "Thank you very much!"

AB: "Um, there has been a ... a fairly recent, ah, January 2000 [sic], ah, encounter between some airliners I guess in Dublin, um, what ..."

TG: "Yes."

AB: "... is there an update on that?"

TG: "Well yes, this, ah ... it took place January the 4th of last year [2004] when, um, pilots of a British Midland Airbus saw a flashing bright triangular object take off from the ground, ..."

AB: "Umm-hmm."

TG: "... ah, as they were passing 3,000 feet over the Slane area, which is ... which is near Dublin. And they saw that this UFO – because they were on the landing pattern ... they were about five (5) or six (6) miles behind an aircraft in front. The aircraft in front was approached by this large, flashing-bright triangular object, um, and apparently the crew experienced a power drain (!) Um, a purple glow was surrounding this, ah, it was a Boeing 737 400-series jet of Aer Lingus, flew in front of the aircraft forcing the pilots to change course to avoid a collision.

The jet apparently experienced wake turbulence and violent shakes, and the outside temperature rose to a hundred and sixty-four degrees [164⁰] Centigrade (!) ..."

AB: "Oh!"

TG: "... for around fifteen seconds (15 sec.)."

AB: "Oh My God!"

TG: "The pilot ... um, now I haven't spoken to the ... the pilots of the Aer Lingus plane yet – it's all been covered up. There's been denial at every single stage"

AB: "Well that's what I was going to say ... that there would be a record of such a temperature rise, for example, in the aircraft's, ah, equipment."

TG: "Art, I'm ... I'm indebted to ... to the principal investigators – Dermot Butler and Carl Nally, um, of Dublin. Ah, one of their colleagues is a pilot himself ... a private pilot. Um, they were the people that got the information in the first place.

I went to Dublin in November to ... to try and get more information. I haven't yet met the pilots of the Aer Lingus plane and, ah, I tried to speak to some Aer Lingus pilots, um, on the flight, um, over to Dublin and absolutely there, um, there was annoyance on the flight deck, ah, that I'd actually tried to get information about the case ... and they refused to talk to me."

AB: "Well, I don't blame them. John Lear is a good friend of mine."

TG: "Yah."

AB: "He's lost at least one (1) job because of what he said."

TG: "I know."

AB: "They can't talk about it."

TG: "Yes, I know John too."

AB: "You know, they have families! They have ..."

TG: "You're right."

AB: "... wives too (!)"

TG: "Let me tell you! Yeah ... exactly!

The aircraft wings were ... were dented. *Badly dented!* Um, the airbrakes malfunctioned *so this was an emergency situation,* **which was declared!** The plane had to be taken out and, ah, it had to be re- ... repaired by, ah, Boeing.

And it's now been sold, ah, to Thailand ... to Thai Airways (!)"

AB: "No kidding?"

TG: "No ... abso- ... absolutely correct.

Um, and this, you know, it also happened to another aircraft ... another aircraft, ah, you know, a couple of hours later on that same day (!)

What is peculiar ... you know, there's ... I talked about a fly in the ointment. There's always a stumbling block in cases, is that I gave an interview, um, in the Irish Star in November and, um, you know, we're appealing for witnesses to come forward, 'cause there are people on the plane who are very frightened by the incident. I can't believe they've all been silenced on landing, you know?"

AB: "Ah, well have they apparently been?"

TG: "I don't know!

I have no evidence of that whatsoever!

I think it's peculiar that someone hasn't come forward, but I don't doubt my sources. And I don't doubt that such ... such events take place.

And I'd like to mention these ... these, ah, triangles briefly. I think some of the listeners will be aware – those ... those of us who sort of 'surf the internet' – of this extraordinary case of a flying triangle seen by a witness ... a musician in Bristol, Tennessee on October 2 of last year.

Very good case and a very good, ah, illustration of ... of the craft as well. And, um, he was nearing an intersection near his home and exited his car to see if there was a *file* (!), because it looked like a ... a fire coming from between the trees and some distance away. And slowly emerged this *enormous triangular-shaped craft*."

AB: "Uh-huh."

TG: "Ah, he started to run, but realized there was nowhere to run to, so he just stood in awe and watched, and it slowly came into full view, ah, estimated at three hundred feet (300 ft.), um, at each ... sides [sic] of the triangle. And only a hundred feet (100 ft.) or so high. In altitude, in other words, blocking out the entire sky.

And there were large domes – as often these are seen. Comparing each dome, he said, to twice the size of a car, um, illuminating the entire bottom. There (3) of those domes, um, at the apex of each corner of the triangle."

AB: "Uh-huh."

TG: "And rib-like structures!

And this has been reported before – I've spoken to several witnesses, including one in the ... in the Midlands in the 1990's, who saw a very, very similar craft with these rib-like structures underneath. Actually ..."

AB: "Hah! Well, Timothy, let me stop you just for a moment.

You're ... you're speaking to a witness (!)

This hap- ... this happened to me. In other words, Timothy, I was, ah, I was coming home with my wife many years ago now and, ah, my wife yelled: 'What the hell's that? (!)' or something to that effect. She was in the passenger seat and, ah, I stopped the car. And we got out ... and a

black triangle not flying, but *floating* (!), Timothy, ah, passed, ah, not more than a hundred and fifty feet (150 ft.) above our head.

Ah, the moon and the stars all went away. It was as classic as you can possibly imagine. It didn't make a sound. You could hear crickets at a quarter (1/4)-mile away.

It floated over our head and then continued, ah, floating toward what we call Area 51, that we're not far from here. But, ah, Timothy, this happened to me!

I've done, ah, paintings and drawings of exactly what it was like – where our car was, what the geography was like … the whole schmear (!) … and what it looked like to us.

I could have thrown a rock at the thing [it was so close!], except Timothy, that I was in shock!

So you see, I've seen this myself."

TG: "I'd love to see ... have a sketch of that, ah ..."

AB: "Oh, I ... I have it!

Ah, (laughs), we had an artist do it for us, and we did GPS [Global Positioning Satellite] readings, and they came out and looked at the terrain, and got everything exactly as it was. *Exactly as it was!*

(I've got a giant thing on the wall of it).

So I'm, ah, I guess ... I guess I'm a believer (!)

Timothy, how can you not be when something that ..."

TG: "Of course."

AB: "... dramatic happens to you!

But you know what?

I don't know, ah, if it was something military? Ah, if it was, then we have the secret of anti-gravity ... apparently."

TG: "Yeah."

AB: "Ah, we have the secret of noiseless propulsion. We have quite a few secret ... and ... and that ... that they would fly it right over my head. And here in the U.S., um, these triangles are appearing over major interstate highways."

TG: "Yes."

AB: "What [unintelligible word scramble] ...it's wild!"

TG: "It's wild.

One would wonder why ... why, ah, you know, if they are American devices, why they would want to show themselves to ..."

AB: "Hang over the interstates, yeah."

TG: "Overtly as they obviously have done on many occasions. Um ..."

AB: "Exactly!"

TG: "Ah, but at the same time I think *some* ... a percentage ... don't ask me to put a number to it, but a percentage of these craft could well be, um, our own. And that ... that applies over here as well.

Ah, 'cause some of them have been seen in ... near British aerospace [sic ... airspace], ah, like Warden up in, um, in the North Country, for example. So it's possible.

On the other hand it could be that, you know, these bases where we are developing all sorts of, ah, new types of aircraft, um, are just being sort of overflown and checked out by ... by the aliens. Who knows?"

AB: "And of course we have endless tales of, ah, back-engineering of alien craft, ah, at that area near me – Area 51."

TG: "Yeah."

AB: "I don't know if that's true, but certainly if we laid our hands on technology like that, we'd do our very damn level best to try and figure out how it worked ..."

TG: "Sure."

AB: "... and duplicate it. That would be a natural thing to do."

TG: "Absolutely! No question about that."

AB: "What do you think, ah, other than ... other than, ah, other than Roswell are the best cases, ah, that you would name?"

TG: "Oh my goodness me!

Um ... there are so many (!)

We have, ah, in Great Britain the Rendlesham Forest case. December 1980, when many, ah, U.S. Air Force security policemen encountered a landed craft ... triangular craft. And, um, this ... events were going on for several days. A deputy base commander, himself, ah, then Leftenant [sic] Colonel Charles Halt at ... at Woodbridge – these were twin air force bases of, ah, Woodbridge and Bentwaters – himself saw some of these things.

There were other craft seen in the skies. And there were traces left.

Nick Pope, himself, was able to get hold of the radiation readings, which were certainly above normal.

There've been all sorts of explanations and attempts to debunk it, you know, and the most recent one being that it was just, ah, some U.S. servicemen, um, going up and down the runway with a red light on ... on top of the vehicle. But, ah, that was the explanation for it."

AB: "Hmpf."

TG: "But you know, this went on for several days (!)

There were lots of witnesses involved (!)

And, ah, I find it an intriguing ... and very important case!"

AB: "In my years of, ah, interviewing people, I ... I had occasion to interview somebody named Travis Walton."

TG: "Yes."

AB: "And, ah, Travis's boss as a matter of fact I interviewed as well. Both of them at once."

TG: "Umm-hmm."

AB: "And they told an incredibly compelling, believable story!"

TG: "Absolutely!

I interviewed Travis Walton. Ah, for me, he's ... he's, um, absolutely on the level. And that's one of the most important contact stories."

AB: "I thought so.

Um, you know, just, you know, as you listen to the man, it was clear that he really had absolutely zero interest ..."

TG: "Yah."

AB: "... you know, prior to this event."

TG: "Umm-hmm."

AB: "It was just a plain man, you know, telling the truth ... I mean it sounded like ..."

TG: "Yes."

AB: "... the absolute truth.

And of course they went through, as you know, lie detector tests."

TG: "Yep."

AB: "Ah, a couple (2) of them.

So you also found that to be a pretty ...?"

TG: "Absolutely compelling case!

And I think one of the most intriguing aspects of it was ... was that nothing was ever said at any time while he was on board the craft. And he had these, ah, good-looking, ah, men and women ..."

AB: (smirks). "That's right."

TG: "... show him around, and he would ask questions. And he ... ah, I think prior to all that he was ... he was playing around with controls on this seat and he rendered the craft invisible ... opaque at one stage, so that he could see out into the ... into the Universe, which was extraordinary (!)

But most important I think is this connection between these ... these , ah, strange, large-eyed, very pasty-colored skin ... beings. Do you remember all [of] that?"

AB: Oh, of course!"

TG: "Who grabbed hold of him, and he fought them off.

And you know, it does appear to me that those were sort of like biological robots, who were subservient to these, ah, more human-like types."

AB: "Huh.

Um, everybody wants to know why – and I guess that's the one question you're not going to be able to answer for us really. Um ... why ... why all this is going on?

And when it's going to come to some sort of ... well, that is a question (!) perhaps I can proffer.

When ... when do you think that general knowledge of the truth about enough of this will be realized? How close are we getting?"

TG: "About five (5) years ago, Art, I asked that question to ... to one of my, ah ... um, friends in Washington. And I said: 'Look, can you imagine how frustrating this is for me? You know, I'm ... I'm – well, at the time I was sort of in my late fifties (50s). And, ah, I said: 'Look, you know, I ... I've been interested since 1955. Um, there's this constant ridicule from the media and the government and everything ..."

AB: "Yes."

TG: "... you know? When is there going to be some official recognition?

And he said two (2) words: 'Stay healthy.'" (AB and TG laugh).

AB: "Stay healthy."

TG: "So ... and since then he and others have intimated that *gradual exposure* is the ... is the only way forward. They are concerned about our reaction of ... of the public.

And ... but I think various, um, safety nets have been put into place – one of which is as I've said the ... the fact some of the facts have been leaked to a number of, ah, journalists. Highly-placed journalists."

AB: "Well Timothy, maybe it's time that you took the test:

I mean if you were given the opportunity to reveal to the world, ah, the complete truth about alien visitation, presence, and motives ... and history ... and ... and you ... it was all given to you, and you ... you could release all the information ...?"

TG: "I ... I could release it, because I'm not an authority!

I'm not a politician.

Um, so I wouldn't really have that much to lose. In fact, I have come out with a lot of this stuff. It's ... it's either just disbelieved or ... or ridiculed. But, um, it's, you know, when somebody in a really, ah, prominent position of authority comes up with this stuff, it's ... it's much, much more difficult. 'Cause it's embarrassing above all – you know, we're not in control.

Nobody likes to look ... look out of control – particularly politicians. They like to tell us as you know, you know how ... how ... how everything's ... everything's great with the world ..."

AB: (laughs).

TG: "... and so on and so forth."

AB: "Yes."

TG: "And, ah, to admit that there's, ah, there are outside forces against whom we have little or no control whatsoever is political suicide. And military suicide as well."

AB: "Ah, quite right.

Um, if they can't control it, then they don't even admit it's there and that certainly is the course they've been following.

It's just that it seems like eventually it does have to break, and I guess you were told then that as long as you can remain for another ..."

TG: "Yes."

AB: "... I don't know, ten (10), twenty (20), thirty (30) years ... whatever ...,"

TG: "Oh, yes! I hope so."

AB: "... ah, then ... then you're likely to get to experience ... the Great Disclosure (!)"

TG: 'Yes. I think what is happening ... what ... what I've noticed (I'm ... I'm not alone in this) is that there has been an improvement in – to a certain extent – in the media ... in the national and international media with regard to reporting on this subject more seriously. I mean, certainly in terms of our recent Freedom of Information Act, a lot of, ah, reports.

And I've got here from [the] 19th of December last year, a huge, huge article, um, in ... in a broadsheet, so *The Independent* on Sunday. An article by a regular, ah, columnist Andy Martin, seen reporting that in Cambridge in England, you know where the University is?"

AB: "Yes."

TG: "He and his family saw this *giant craft* just hovering and going over ... over him. No more than, ah, at a height of more than four or five hundred feet (400-500 ft.). No noise, he said. Dark outside. Outline of a craft. It was nothing like an aircraft. There were no wings poking out the sides. Um, definitely jumbo-sized, and it wasn't going up and it wasn't coming down. And you know, that's ... that's from, you know ... a good journalist!

And another journalist, the editor of ... of, um, a paper in southern England – the *Southern Daily Echo* – um, reported seeing a triangular craft in the New Forest that's in ... that's in Hampshire."

AB: "All right, all right, we are at the top of the hour ..."

TG: "Yes ... okay."

AB: "... and we're going to go to the phones here shortly.

Hold on, Timothy.

Um, I'll tell you what I told ABC. I told them that, ah, after seeing what I saw – whether it's us, ah, our back-engineered craft or even our own craft that now defy gravity OR it's their's – either way ... either way disclosure of this ... oh, that [would] be a Really Big Story!

Right?"

* * *

AB: "As I said, ah, with the ABC special coming up on Thursday the 24th, 8 to 10 [p.m.] – a major page in UFOlogy gets turned! A major network finally doing a serious investigative report on UFOlogy.

Ah, my guest is a UFOlogist – I guess that's fair – Timothy Good, one of the world's best, available for your questions. If he knows the answer, I'm sure he'll take a stab at it.

Your opportunity with Timothy Good, coming up!"

* * *

AB: "Okay, once again Timothy Good, ah, with us this evening. One of the world's best UFOlogists ... a lot of books under his belt.

Ah, Alien Update, ah, is one. Unearthly Disclosure: Conflicting Interests in the Control of Extraterrestrial Intelligence; Alien Base: Earth's Encounters with Extraterrestrials; Alien Liaison: The Ultimate Secret; Beyond Top Secret: The Worldwide UFO Security Threat; and ... and, of course, Above Top Secret: The Worldwide UFO Cover-Up. ...

Ah, once again, here's Timothy Good, and I would like of course to get to some calls this hour.

But Timothy, is there anything that we didn't cover, you know, in the first couple of hours that, ah, that we absolutely should?"

TG: "Oh gosh! There's tons of stuff, Art.

Um, I guess it would be more of interest to listeners if I mentioned things that they may not be familiar with at all?"

AB: "Sure."

TG: "Now for example ... well, they may be vaguely familiar.

Back in March of 1997 there was a report that a large triangular craft was seen above the house of Michael Howard, who was then Home Secretary living down in ... in ... in, ah, the marsh ... marshlands of ... of, ah, of southern Kent.

And the event was witnessed by a journalist, who I spoke to. There were other witnesses involved who ... who subsequently came forward.

This craft alternately hovered right above Michael Howard's house. (He's now ... he's currently leader of the Conservative Party and he's hoping to win, ah, the election, which we're going to have in May).

Um, but I have gotten an official, ah, request ... has been put in for information about the event and his opinions, and so forth. And I've

already had acknowledgment that he will indeed be replying to this. So, um, stay tuned. I'll let you know what he says about it.

But interestingly this craft alternately hovered right above his house and then retreated – you know, like four or five hundred yards (400-500 yds.). Then it came back again, and this was going on. And there was one stage ... all the alarms were set off, because obviously being Home Secretary at the time, ah, a lot of security guards around the place and dogs, and so forth. And there was pandemonium (!) And this was witnessed by a number of people, including some, ah, some firemen.

So ... something happened. I think ... and I think that's ... that's very interesting. And, you know, talking about, as we were earlier, about politicians and UFOs, ..."

AB: "Hmpf."

TG: "... but this is an election year. And the least likely subject that any politician is going to get involved with is UFOs (!) That's for sure!

And as far as, ah, your President is concerned, um, I do know someone who is, ah ... ah, a friend of his and has on several occasions asked him. And the last time he asked him was in two thousand ... late two thousand and three (2003), I believe."

AB: "Umm-hmm."

TG: "And he said [to Bush]: 'Oh, c'mon, you know, tell me! ... blah, blah, blah.'

And this chap said: 'Ask Cheney.' ... (That is what George Bush replied!)

Whether that's ..."

AB: "Ask ..."

TG: "... helpful to anybody, ..."

AB: "... Cheney?"

TG: "... I don't know, but that's what your President said regarding the UFO subject."

AB: "Why do I think that's a reasonable answer? (!) (AB laughs).

I think so too.

I ... I have a feeling if anybody knows it's, ah, Dick Cheney.

All right, um, two (2) things ... "

TG: "And George Bush, Senior!"

AB: "Listen ..."

TG: "Former President Bush knows a great deal about the subject. That I can tell you."

AB: "Oh? Okay."

* * *

Aud: "Just know that in this field [UFOs] if you really do investigate it too far, um, you will have, um, uncomfortable situations where people threaten you. I was just wondering if you've been threatened too as well?"

AB: "That's a very, very good question.

Ah, Timothy indeed, as you begin to probe secrets and get into areas that perhaps the government is not yet ready to be disclosed, are there ever times when you have been ... do you feel in danger?"

TG: "First of all, I appreciate the ... the ... I'm glad you raised this question. ...

First of all, I've never been threatened. *But* I have had intimidation in the form of, um, interference with telephone calls. Most extraordinary shrieking sounds ... howling sounds on the telephone when engaged in interesting conversations – particularly with my American friends.

Um, also on several occasions had ... had ... had items taken from my room. I was in, ah, I think it was Virginia in the 1970s, ah, touring with the London Symphony Orchestra at a motel. I noticed two (2) government pool cars were outside – I didn't pay too much attention to it, and I went to lunch. And when I came back, um, my room ... someone had been in my room and taken my research notes, but left expensive cameras and zoom lenses, and stuff ..."

AB: "Ha!"

TG: "... in the room. So I had no research material with me.

Um, but things like that have happened. I could go into it to other cases.

Um, there was a case in ... I think it was in Raleigh, North Carolina when I was appearing on a local television station, and this is my own fault. I thought I'd just test the system. I noticed that there was, um, a ... a U.S. Army base ... headquarters of the U.S. Army Reserve, um, in Raleigh, North Carolina not all that far from my motel. So during this television interview I happened to mention the alleged briefing about the UFO situation, which was given to U.S. Army Reserve officers in Puerto Rico in the late, late '80s. And, ah, I just thought ... I wondered if there would be any repercussions?

Well, when I came ... I also advertized the fact that I would be giving a small talk to some invited guests at the motel ..."

AB: "Umm."

TG: "... at lunchtime."

AB: "Umm-hmm."

TG: "I went back, I gave the talk, I came back to my room, and a lot of stuff had been stolen, um, from my girlfriend as well ... at the time. Um, a lot of stuff.

Now, it could have been somebody ... could have been an inside job. I must state that at the outset. At the same time the police were not that cooperative. Ah, I ... the best I learned was that the hotel had hardly ever been broken into. There were about four hundred (400) other rooms. No... nobody else's room had been taken.

So do you think that's intimidation?

Do you think that was, ah, done by some military guys?

I don't know. I keep an open mind about it. But those are some of the things that ... that have happened to me."

AB: "So obviously they've ... they've perhaps suggested to you that ... what? You should be slowing up a little. You should be more careful about what you say. (AB grins). What do you think the message might have been?"

TG: "I don't know."

AB: "Well, that's ..."

TG: "Probably ... probably the latter."

AB: "... a fair answer."

* * *

Aud: "Um, I, ah, wonder if the gentleman would know of a way for a human to initiate [alien] contact should one desire it?

And would he care to comment on, ah, I hope I've got the name right ... Billy Meier?"

AB: "Ah, okay, very good! Actually both good questions." ...

TG: "Yes, the way to initiate contact – my goodness me! Um, heh, some people don't need to initiate contact apparently, especially if they're abducted out of their bedrooms in the middle of the night."

AB: "Would you say she should be careful what she wishes for?"

TG: "I ... I would actually. Um, my feeling is that one should always ask for protection, um, in these cases.

One way to initiate contact which worked for me on two (2) occasions – which I discussed on this program, I believe, ah, back in August when I was last on, ah, is to try telepathy. These beings are very telepathic, and I don't know about the current, ah, timeframe, but there were a number of these people based on our planet at the time, and they can pick up your thoughts. And they have interacted with human beings, who've, ah, sent out telepathic signals.

It certainly worked for me! And I had my own very close encounter through that.

Ah, second part of your question: As far as Billy Meier is concerned, um, you might be surprised to learn that I actually discovered Billy Meier (!), ah, when I was in India in 1964. I didn't meet him then, but I met his friends. This was long before the story had ... had come out.

And, I then traced him to Switzerland. And I spoke to him and I thought he sounded sincere. However, in the 1970s when Lou Zinstagg was, ah, who ... who got to know him, 'cause I gave him ... I gave her his address. Ah, she ... she spent a lot of time with him and thought he was sincere and everything, but I became very, very dubious about the photographs that he was ... he was promoting, um, for all sorts of reasons, which we probably don't have time to go into now.

And I know many people think they're genuine, but I ... I do not. But I do think that Billy Meier did have contact at some time, and then maybe just a

sort of [to] gain more credence, um, in the stories – he produced the photographs. But, um ..."

AB: "Huh. Huh ... that's interesting."

TG: "He's an interesting character, that's for sure."

AB: "Um, that brings to mind another question that I really have to ask. Ah, I look at UFOlogy and I've been looking at UFOlogy and interviewing UFOlogists, and, ah, both sides of the question for years and years and years, Timothy. And the one thing that I have learned is that UFOlogy is probably it's own worst enemy."

TG: "Yes."

AB: "And, ah, at various times people come on this program and they virtually shred each other. As if it's not tough enough, ah, with the mass media out there and ..."

TG: "Yeah."

AB: "... and the government and all the institutions laughing and ..."

TG: "Yes."

AB: "... it's ... it's not tough enough, we have to destroy ourselves (!) Um, you have comments on that?"

TG: "Yes, well I'm afraid there's always going to be rivalry and politics, ah, in any sphere of ... or in any subject. Um, and UFOlogy's, ah, no exception.

Um, I think it's not just ... it's not just, ah, people, you know, sort of knocking each other that's ... that's, ah, the problem. There's also I think the people with wild claims (!), ah, really wild unproven claims, um, who ... who come forward and get an awful lot of attention.

I'm not going to go into any names, but I think that does a great deal more harm to the subject and it plays into the government's and the media's hands when ... when people make these wild claims. I don't know what you think about that, Art?"

AB: "Heh!

What percentage of, um, UFO stories and contact stories, and all the rest of it, ah, would you say, um, is legitimate?

And ... and how ... and what percentage, ah, would you think are outright frauds?"

TG: "Wow! I'm no good at math, Art, but, ah, I ..."

AB: "Of those ..."

TG: "Outright frauds! ... I don't know.

Honestly I don't know, but I would say the percentage of **absolutely legitimate** cases and legitimate claimants, ah, is ... *is, um, relatively small (!)*"

AB: "Uh-huh!

Um, so you would say that the bulk of them *or even the majority of them would ... would be fair*, ah, if not frauds, are simply untrue?"

TG: "Well, or ... or a mixture. You know ... you know, people suffering from delusions or ... or ... or what.

But you know even if it's the minority, a minority, can be forty-nine percent (49%), Art, which is a high percentage ... [unintelligible – must be great?]"

AB: "Oh, yes! Oh, absolutely! Yes, of course!"

TG: "But I don't know. As I say, I'm no good at math. I haven't actually, you know, gone through all the tens of thousands of cases there are!

I mean, there's so much stuff. We suffer from a surfeit of information. It's not ... a lot of people say there's not enough information to go on – there's too much information to go on!"

AB: "Let's try ... okay, lets' try this approach:

Of the claims that you have investigated, how many times have you found yourself, ah, disappointed?"

TG: "Many times (!)

Many, many times."

AB: "But not enough that you ... you dismiss the entire phenomenon obviously?"

TG: "Obviously not."

AB: "Yes.

Okay, that sure does make it a tough job, ah, Timothy. A really hard job, because most of these claims by their very nature are pretty fantastic, aren't they?"

TG: "Yes ... yes. Absolutely."

AB: "Even ... even the ones, ah, for example, the photograph that I've got up – I hope you get a chance to see it.

Um, it's just a picture of a picture, but it represents *exactly* what I saw, even though the proportions are scrunched down a little – sorry for that. That's exactly what I saw! And it's how close to was to my eye! When ..."

TG: "I can't wait to get online."

AB: "... when you've seen something like that it changes you forever (!) ..."

TG: "Yes."

AB: "... or at least until you get a legitimate explanation for what otherwise cannot be!"

TG: "Yes."

AB: "Um ... anyway."

* * *

Aud: "I wanted to ask you about UFO abductees. Ah, in many cases they claim there is a ... a chip imbedded in their neck or arm, and they had them, ah, surgically removed.

Ah, my question is: Is there any assessment or analysis on just what exactly these things are? And are they man-made?"

TG: "Well ... well, ah, first of all let me mention, ah, Roger Leir – L-e-i-r – has written a book on his investigations. His, ah, extraction of some of these objects from ... from, ah, quite a number of patients."

AB: "Have you looked into these?

I, of course, have interviewed Dr. Leir"

TG: "Yes!"

AB: "Roger's a good friend. And have you looked into his book and his re- ... his claims?"

TG: "Yes I have!

But I ... but, ah, not as thoroughly as I ... I would like. For example, I haven't seen the ... the famous video of the *moving implant (!)*

I expect you are aware of that ..."

AB: [Unintelligible].

TG: "... where it moves around underneath someone's arm."

AB: "Ah, actually it was an ear!

Maybe an arm as well, but, ah ..."

TG: "Okay."

AB: "But it ... Whitley Strieber, a very good friend of mine – co-author of the book we wrote ..."

TG: "Yes."

AB: "... ah, became the movie.

Ah, he had an implant that moved.

They tried to retrieve it from his ear ..."

TG: "Yes."

AB: "... and the damn thing ... it kept ... scalpel touched it – AND IT MOVED!"

TG: "Yes. Um, also the late, ah, Dr. John Altshuler – a hematologist – and the first to investigate the animal mutilations was also the first to, ah, excise unknown foreign objects, ah, from ... from a few patients. And one of which he thought was just, ah, you know, sort of aggregation of ... of human tissue. Others ... one other one he ... he ... he couldn't explain. He was ... he was just baffled."

AB: "Yes, um, all right."

TG: "I think ... I think ... I think there could be something to it, but again, I think a lot of things ... everyone thinks they got chips embedded in them, you know? (!)"

AB: "Ah, well there are a lot of those.

Timothy Good is my guest. UFOlogist in Great Britain, all the way across the ocean. You have a question for him? That's what we're here for.

I'm Art Bell, and this is Coast to Coast AM."

AB: "It is true that Britain just got ... just literally got a Freedom of Information Act and, um, apparently Timothy feels that, well, they were ready for it by the time it came out.

Ah, you may recall in the Roswell situation when, ah, we had a, ah ... um, a man in Congress who actually went after the information. The only answer he ever got was: 'Whoops! It looks like ..."

TG: "Congressman Schiff."

AB: "Yes. ... and it looks like, ah, these files have been destroyed (!)"

TG: "Yes."

AB: "'Or lost!' I think they said ... or lost."

TG: "Or both."

AB: "Ah, or both.

And you think much the same thing happened there in Britain with your new Freedom of Information Act?"

TG: "Um, probably ... in some cases, yes."

AB: "Hmpf. All right."

* * *

Aud: "Um, how many people do you believe – if you believe ... I'm not sure you do or not – are possibly descendants from, ah, an alien race or, ah, people from the UFOs and stuff, you know?"

AB: "All right. Well, it's a reasonable enough question.

If ... if it's a genetic connection, then how many of us do you feel are descendants of aliens?"

TG: "Oh, I ... I think, ah, indirectly they're ... maybe the whole planet has ... has been affected in some way by genetic manipulation going way, way back."

AB: (under his breath). "Oh! So one way or the other ..."

TG: "I don't, you know ... one way or the other.

I can't say that ... that I know that to be a fact, um, but you know it's my belief that there was genetic manipulation of ... of primitive Man when, um, we first made our appearance on this planet."

AB: "Another question would be and I think I'll ask you: Ah, do you think that, ah, there's any possibility that we are not the first? And by that I mean the first intelligent ..."

TG: "Species?"

AB: "... occupants of Earth?"

TG: "I'm glad you raised that, Art. I've written about that in my books. Ah, I think it's quite likely that ... that many, many eons of Time ago there were advanced races, who maybe colonized this planet, and they were through some cataclysm were forced to seek other habitation.

In that connection ... I'm very interested in. I ... I have a friend called Rubens Villela, he's a scientist ... a meteorologist from Brazil. He's also a former CIA [Central Intelligence Agency] communications specialist and he's been on numerous Atlantic expeditions, um, as a meteorologist, ah, including many with the United States Navy.

He had a type of contact with ETs and was given proof of their, for example, their ability to change weather, because he was a meteorologist. And they certainly proved their existence to him. He saw their craft.

And he said: 'These cosmic visitors proclaim a genetic origin linked to our own species on Earth ..."

AB: "Uh-huh."

TG: "... though they inhabit a dying planet where we would have to manipulate Time and Space dimensions to reach."

Ah, that's what Rubens Villela wrote in a letter to Michael Collins, the Apollo 11 astronaut in 1979."

AB: (under his breath) "Whew!"

TG: "And remember he himself acknowledged that they were several ... there were several species coming here. And in ... in particular with the species that he was familiar with, he said: 'They desire an alliance without fear and offer us protection against impending cosmic dangers.'"

AB: "I ... I wonder ..."

TG: "He also learned – and emphasized – ah, Rubens Villela:

Certain other alien species are inimical to human beings (!)

So there are ... there are dangers."

AB: "Have there been mentions, Timothy, of, ah, not just bombs that we might do ourselves away with, but our current environmental situation which seems ..."

TG: "Absolutely!"

AB: "... quite distressing!"

TG: "Absolutely! Um, the contactee, for example, Enrique Castillo Rincon – I've written several chapters about him in my last book, *Unearthly Disclosure*. And he was given a tremendous amount of information about coming cataclysms, um, on this planet.

Um, he says one of ... he actually says: 'I do not give an account of the calamities announced by the [unintelligible] because they had information covering many years as to how the facts will unwind.' And he goes into some detail.

Um, I'm just, ah, checking through my book here – I can't remember everything. Ah, he was taken to several alien bases, um, one of which was under the Pacific Ocean in the Marianas Trench, which is about 11,500 meters down (!) But the base was located in a wall of that, ah, of that ... that area. And, ah, an extraordinary story!

And he was given information about, um, coming events on this planet, including ... including enormous, ah, geological cata- ... cataclysms. And the fact that the Sun ... there would be problems with our Sun (!), which would lead to severe ... very severe problems on Earth (!)

And he goes into some detail about that.

I ... I can't remember chapter and verse, Art, um, I'm sorry right ... right now, but, um ..."

AB: "Ah, that's quite all right, Timothy."

Aud: "Ah, I was wondering what is the significance of the triangle versus the disc?"

AB: "Huh."

Aud: "Did ... is ... is the ... are the Aliens doing the disk and maybe Man did the the triangle, because it was better to maneuver electrically now?"

AB: "Boy, I'd like the answer to that one myself!

Ah, Timothy?"

TG: "I didn't actually hear – the triangle and the what?"

AB: "Well, he was asking about the significance of the triangle versus the disk. In other words, he was suggesting ..."

TG: "I'm sorry, the voice ... his voice was incredibly distorted."

AB: "I understand that the disk might be Alien he felt, while the triangle might be more Earthly in origin?"

TG: "No, no, no ... no ... no ... no! The triangles have been seen for a very long time. Ah, it's just no way they can ... they can all be, ah, terrestrial.

So, ah, you know, they have many different types of craft. Many, many different shapes have been observed, and triangle is ... is just one of them."

AB: "All right."

* * *

Aud: "If in this day and age we live in such a New Age ... such a ... all different things, you know, anything goes – **why** would the government hide these things?

And if these things exist, just tell us!

I mean, obviously I have my own opinion on what these are – just like most Christians – but ... and I have another quick question:

Survey 'true' Christians – and if you ever have done that – to see exactly what the percentage of their sightings or their abductions would be. I think you'll find that it's almost zero percent (0%)."

AB: "May I ask you a question, caller?"

Aud: "Yes, sir."

AB: "If, ah, it turned out that you were entirely wrong, and this really was, ah, various other intelligent races visiting Earth for whatever motivation, and that actually turned out to be the case irrefutably ...,"

Aud: "Hmm?"

AB: "... how disturbed by that fact would you be?"

Aud: "Well, ..."

AB: "Honestly."

Aud: "... let me just say this quick: When God created the Universe, okay, before Satan fell, we don't know what was out there. When Satan fell, the Earth and the Universe was corrupt forever. So yes (!), there could be.

Because when God said: 'Let there be ...' – the Universe is still 'being,' okay?

That's all I can say about that.

How upset would I be?"

AB: "Yes, sir."

Aud: (laughs) "As a Christian and a follower of God and Jesus ..."

AB: "Yes?"

Aud: "... I would ... I would accept it.

But ... but the point is though ..."

AB: "Would ... would you accept it if it included a story that, ah, your ... your vision of Creation ... your ... your belief and faith in the way Creation occurred – *just wasn't so?*"

Aud: "Well, see that's a hard question to answer ..."

AB: "I accept ... I ..."

Aud: "... because that's ... that's my beliefs.

And you know what? Let me say this, Art: I believe you're a man that's searching. I really feel that. I've listened to you for almost a year. And God, I hope you find the true ..."

AB: "Well, the ... answer my question though. I know it's hard."

Aud: "Yeah."

AB: "But answer it anyway. If it turned out *irrefutably* that they were our Creators – not they way it's in the Bible ..."

Aud: "Umm-hmm."

AB: "... that would put you in a tilt, wouldn't it?"

Aud: "Well, I guess that would ... well, let me ... let me just say this ... okay, I understand."

AB: (laughs).

Aud: "If ... if there is a God that is a perfect God, right (?), and makes no mistakes, then why would He make the horrible mistake of sending His Son to be Our Savior?"

AB: "All right.

Well, it seemed to me that Timothy seemed to suggest, um, if you were listening carefully between the lines, that Jesus might have been an alien (!)

Timothy?"

TG: "I ... I did suggest that. Ah, Jesus said in the Book of John on two (2) occasions, um, 'I'm not of this world (!)'

Now, I'm ... I'm sure Rick will say: 'Well, of course that was just, ah ..."

AB: "Yes."

TG: "... um, 'metaphorical,' um, which it well might have been – I wasn't there!

But there ... you have ... you can't get away from ... from the Star of Bethlehem, the ... the Bodily Ascension into Heaven surrounded by two (2) beings in shining raiment. Ah, His remarkable abilities and so forth. And, ah, the appearance to the conversion of ... of Paul on the road to Damascus when ... when, ah ... ah, Jesus appeared in some kind of brilliant object in the sky.

Things like that, um, I think ... and ... and of course the Angel Gabriel. What are angels? They're not ... we're not creatures with flapping wings. An angel simply means 'a messenger,' and they're normally described – even if they come from the heavens – meaning the sky – prob- ... possibly as ... as human beings ... human-type beings. And that goes into the Old Testament as well, because people who encountered mysterious beings from the sky said and this was their appearance – they had the appearance of Man."

AB: "Umm-hmm.

Um ..."

TG: "That's Ezekiel I believe."

AB: "All right.

Well, would you say that people like [him] – and he sounded like a very nice guy – "

TG: "Yes."

AB: " – but he did dance around that question quite a bit as in not actually answering it. Ah, he would ... he would go on tilt for sure ..."

TG: "Umm-hmm."

AB: "... ah, if that kind of irrefutable proof was presented to him. Because it would ... it would violate everything he believes and has faith in."

TG: "Well, I'll just ..."

AB: "And ... and Brookings Institute I think said that for that very reason we couldn't disclose this."

TG: "I think, um, religious sensitivity is certainly one of the reasons for the cover-up, because of the ... of the connection. And, ah, I can sympathize with governments, um, on ... on that level."

AB: "So can I!"

Aud: "A while back ... last year when you were in Tucson, Arizona ..."

TG: "Yes?"

Aud: "... you interviewed a friend of mine about his, ah, encounter when he was, ah, back in the seventies (1970s) when he was in the Navy."

TG: "Yes, Bill!"

Aud: "Yes."

TG: "Indeed!"

Aud: "And ..."

TG: "I did indeed!

And we talked about that, ah, he ... he ... he came on the show in August, ah, with George Noory. And a terrific story!

And I interviewed him for many hours and I find it's a ... a compelling story! Ah, the only ... he only got a couple (2) of points wrong:

The incident took place, ah, not in ... in 19, ah, 75, as he thought, but it was 1976 ..."

Aud: "Umm-hmm."

TG: "... um, on board the USS Forrestal when, um ..."

TG: "I ... I want ... he's not on the Internet, of course.

Um, and I was going to phone him, but it was ... it just slipped my mind at the last time, and I ... I ... and so forth. But I ... 'cause I would have liked him. Usually he listens to this show always, so ..." (TG laughs).

Aud: "Yeah, I don't know where he is tonight.

I tried to get a-hold of him."

TG: "Give him my ..."

AB: "I ..."

TG: "... my warmest regards."

AB: "... I can tell you this – he wouldn't have a chance of getting in. We've got, um, you know, every single phone line is locked up."

* * *

Aud: "And I too am a Christian, but my ... all of this is, you know, rather, ah, a spine-tingling type of conversation and realization. But my question is do you have any, ah, any stories of the times that you've come across aliens or stories of aliens or UFOs that just gave you a sense of ... of evil? Um, admittedly?"

AB: "Okay, that's an excellent question!"

TG: "It's a very good question! And, um, yes indeed, I have! And whether these beings are aliens or from other dimensions, you know, it's not a safe ... necessarily a safe Universe with beings of sweetness and light (!)

I mean, as above ... so below. There's ... there's good and there is evil, and undoubtedly *in my opinion* there are beings from elsewhere, whom I would term 'evil.' Definitely!"

AB: "Um, then he would say if he were still here: 'Well, yes ... evil. Of course ... evil, because, ah, really we're not talking about aliens – we're talking about Lucifer and his influence here on Earth.'

Christians would say: 'Well, that's real ... sure it's real – it's Lucifer at work!'"

TG: "Well, I can't comment on that.

Um, I'm not sure if I believe in a specific being that's, ah, responsible for ... for evil. I think, ah, it goes way beyond that (!) But probably beyond my comprehension (!)"

AB: "Well again, though it comes back to the faith that so many ... I ... I mean it's so strong in the world! Ah, it's not as though it's changed!

Ah, Christians believe what they believe. We have people in the world who are willing to kill us, ah, unless we are willing to believe what they believe."

TG: "That's right."

AB: "I mean, people are living and dying and fighting wars for what they believe about God (!)"

TG: "True. And, ah, a lot of Christians went around in the tens of thousands killing people, who didn't believe in Christianity as well. So I mean it ..."

AB: "Right ... yes."

TG: "But we've ... I think we've sort of hopefully, ah, hopefully got past that stage now. But, um ..."

AB: "Well ... maybe. But isn't what you have described – when you really get down to the barebones of it – almost a 'new religion'? (!)"

TG: "Yes!"

AB: (grins).

TG: "Well, in fact, many, ah, religions have been engendered as a result of people becoming fanatically obsessed with UFOs (!)

And ... it's, ah ... um, an explicable link between these subjects (!)"

AB: "It is! Ah, on ... on the one hand, they're ... they're linked. And on the other hand, they're at absolute odds, ah, with each other (!)

And, I ... I think that's what prevents full disclosure – but ... maybe I'm wrong about that.

I've thought about that all these years ever since the Brookings report.

I don't think much has changed in the world, even though we have a more modern world with all these great con- ... technological conveniences. *It's still people's faith!*

Ah, and ... and a lot of what's said by UFOlogists – really bottomline, Timothy – it does challenge that faith."

TG: "Yes, absolutely!"

AB: "And so ..."

TG: "And a lot of people have very, very peculiar beliefs, um, on all sorts of subjects."

AB: "Uh-huh.

Well ..."

TG: "Not just ... not just UFOlogy."

AB: "I would think the open-minded ones then would, ah, and should read your books.

Is there any first book – since you've got so many – that people should read? Probably your latest, I'm sure, right?"

TG: "Well. no. I wouldn't recommend that to start off with."

AB: "Oh!"

TG: "Unearthly Disclosure really goes to the ... to the outer limits.

Um, probably the best is Beyond Top Secret."

AB: "Beyond Top Secret?"

TG: (experiences a coughing fit).

AB: "And ... and I think probably, ah ..."

TG: "Art, unfortunately nearly all these books are out of print.

I think, ah, there may be some copies of *Alien Base* and *Unearthly Disclosure* available on Amazon, but, ah ... um, *Above Top Secret* ... *Beyond Top Secret* ... *Alien Contact* ... and so forth are all out of print. And, um, you can try Amazon, but, ah, I wish some of them would be reprinted."

AB: "Well, maybe they will.

Timothy Good, it has been a pleasure as always to have you. All the way across from Great Britain. Thank you!"

TG: "Thank you very much indeed, Art."

AB: "And Good Night, my friend.

And don't forget, folks – set those VCR's [video cassette recorders] and whatever else it is you've got: Thursday, 8 o'clock, 7 Central – ABC: *UFOs Primetime* – ABC with Peter Jennings.

I'm Art Bell from the high desert.

It is comin' up on 2:00 a.m. here in the wet desert. Good Night."
