AB: PN is from East Islip, NY

PN: Electrical engineer; graduate from Univ. of Tampa and additional education at Polytechnic Institute of New York

Worked in the “military-industrial complex – including [on] secret projects – for many years.” This includes the Montauk Project.

Semi-retired now.

\* \* \*

PN: The Montauk Project is still ongoing – “traces back to 1947 when they decided to restart the Philadelphia Experiment to find out what actually went wrong and why the people on the boat were not able to take the field.”

The Philadelphia Experiment was attempting to make a ship invisible to radar, but the ship disappeared into hyperspace ...

Montauk Project – split the Philadelphia Experiment in two: the engineering aspect went to Los Alamos National Lab and the human factor research went to Brookhaven National Lab on Long Island, [NY]. This occurred about 1950. The Montauk Project was part of the Phoenix Project – “research into the human mind.”

PN: Cannot discuss Brookhaven’s human factor research in detail because of his signed security oath. But he can discuss the Montauk Project, because “that I never signed for. In fact, officially I never existed on that project.”

\* \* \*

PN: Al Bielek is “very controversial.” The Philadelphia Experiment is only one test of many [that were undertaken]. The difference between Bill Moore’s book and Al Bielek’s account is that Moore’s book is based on his [incomplete] research – “which is why it’s somewhat confusing” ... Bielek’s account is based on his “personal experience.”

“The Philadelphia Experiment did happen – it was definitely a high energy physics project.”

“Nicola Tesla had an input [in]to it in the beginning. Dr. John von Neumann definitely did work on it – he himself told me that.” ...

“Al’s idea of what happened on the boat is pretty much accurate,” because PN heard the same from Duncan Cameron, “who was also on the boat with Al. ... Really, I don’t have any quarrels with Al ....”

AB: “So then you think [Al Bielek’s] story is essentially correct?”

PN: “It’s essentially correct. I think he may have missed some of the items and some of the points.”

They were pulsing “a magnetic field through extremely strong levels. ... It is highly possible to bend space and time – now, if you can control this” ... [you’re in business!]

AB: “What was the mission of the Montauk Project?”

PN: To research the human mind’s intervention with electromagnetic fields. “Mind control technologies.” Research was conducted at the old Montauk Air Force Base – about 40 miles from Brookhaven Lab – so as “not [to] be under the watchful eye of the Congressional committees.”

AB: “When you say ‘mind control,’ what exactly were they able to do to a person?”

PN: “They were able to essentially inject a thought into a person’s mind – make them believe it’s [their] own thought, and control what you’re thinking and therefore, have some effect on what you’re doing. ... They could literally read out what you’re thinking. ... They can modify your thought pattern.”

AB: “Ohh ...”

PN: “And this was done at a distance using radio waves. ... That’s what this whole thing was about. ... Up to thousands of miles – we’re not exactly sure how far it was.”

PN: “They used mind control to make anyone who worked on the project forget what they did.”

AB: “What technology is behind that?”

PN: Pulse waves with specialized modulation. "Human beings are sensitive to pulse waves."

"It's a true pulse – [a] frequency-hopping pulse."

"A random-ordered white noise pattern."

"It's a very unique type of radio signal."

AB: "How would you make it specific to any particular biological entity?"

PN: "You have to identify the person's 'signature' as the signal [thought] is being generated." ... The overall signal was generated by a human being. "They had a group of sensors which picked up his holographic-thought pattern, processed it through a very large computer system, and then put it into a modified radar transmitter."

Montauk was essentially a mind amplifier ... which led to all sorts of things – mind control, 'precipitation' [perception?] of objects ... they were able to create an object out of the background ether." (!)

AB: Did it actually create an object or did it create the vision of an object?

PN: "It could be either one, depending on the fidelity of the transform being produced through the equipment."

AB: "What could you get an individual to do? You say you could put an idea in an individual's mind – how much power of suggestion could you accomplish?"

PN: "I really don't know – the information was very compartmentalized." He heard that they could get an individual to do about anything they want ... [but this was secondhand]. "That almost the sky was the limit!"

AB: "God, that's incredible!"

PN: "You could program somebody to be an assassin ..."

AB: "Preston, is Time Travel possible?"

PN: I know of "the remnants of a time machine." ... "But being that we're compartmentalized, I have no knowledge of how successful the time portal was ...."

New theories are saying “there are multiple entities where time is different,” by they co-exist, “and it’s possible to move from Point A to Point B in Time, and they’re saying it’s possible to go into the future ....”

To me, if you can travel into the future, it’s predestined as to what’s going to happen. [PN’s belief, not his knowledge – JS.]

PN: “There are three (3) levels of stealth:”

- 1) “the radar cross-section, which is how much radar signal does the thing reflect;”
- 2) “absorbing the radar signal;” and
- 3) “electromagnetic bottle.”

But the electromagnetic fields are dangerous to humans [who have a] “tendency to become disoriented!”

AB: “What are they doing at Montauk now?”

PN: “Well, present-day, it’s a state park ... known as ‘Camp Hero’ park – only thing is, it’s *closed* to the public (!)”

Fence all around it, security on the base, electric gate, two power lines going in capable of multi-megawatts – “now what’s a state park doing with multi-megawatts” power lines?

AB: Good question.

PN: Claim they are undertaking environmental clean-up, *e.g.*, “asbestos removal,” but PN believes this is a cover for other activities taking place there now.

We believe the active areas are underground – we’ve had reports ... of deep, level underground, which is huge (!) ... goes down for miles (!) – [then admits] some of this could be exaggeration.” Could be a particle accelerator.

Ostensibly just a bunch of derelict buildings on the surface.

AB: “Wouldn’t it be possible to literally follow the power lines and find if and where they go underground?”

PN: We believe we know where it goes underground. Also can hear the whine of a turbine underground.

AB: What do you think they're doing?

PN: Something electromagnetic. It's all "speculation and conjecture." At times, you can pick up a pulse transmission ... "There is some sort of data link – what the purpose is, I really don't know."

AB: "Is there mind control going on now?"

PN: "There are all sorts of transmissions going on right now – whether accidental or on purpose, I really don't know." They seem to have an effect on our consciousness at a subliminal level.

AB: Can mind amplification be done with any human being or do some minds "lend themselves more towards that?"

PN: "Theoretically it can be done with any human being, but you want a person who is trained" to be able to concentrate. Requires special training.

Duncan Cameron was one such human being. But he could "only concentrate on one such thing at a time" – he could not multi-task.

"The human being has to create a virtual reality in his mind and the equipment picks up on this."

AB: So you're saying an individual using this process with that equipment, could create anything from a material object to a being, an entity, or a monster?

PN: "We know they could create an *object*," but they had trouble creating a human being ... too difficult / complex – "much more detail."

AB: "How far have they come in the fidelity area?"

PN: "I don't know. Since '83, I have no knowledge."

\* \* \*

AB: "What part did Montauk play in the Philadelphia Experiment?"

PN: "Well, Montauk is the place where the two sailors [Duncan Cameron and Edward Cameron] came" from the Eldridge. Montauk ... was the other end of the time loop from Philadelphia."

Actually three (3) points – "they used '63 [August 12, 1963] as well."

AB: “What made Montauk the other end[point]?”

PN: They linked some of the equipment, some of the people, and “used the earth’s biorhythm effect” to link Philadelphia and Montauk through space and time. Rumors are that this project opened up a major rift in space-time – a hole in hyperspace – to allow all the UFOs to come in since 1947.

Aud: Is “any of this technology, *alien* technology?”

PN: “Some of it is rumored to be alien technology – I do believe that this is testing alien concepts. Either gathered from downed UFOs or from the ‘legendary alien treaty’ with the U.S. government, you know, trading people for technology.”

AB: “Do you believe that that is true?”

PN: “I’ve seen nothing to say ‘yes,’ and nothing to say ‘no.’”

AB: “That’s careful. ... That’s a careful answer.”

PN: “At Montauk they were trying to bend the space-time continuum and it takes tremendous amounts of power. Any quantum physicist will tell you that.”

“The Montauk Project was much [more] finessed [than the Philadelphia Experiment]. That’s why the Montauk Project controlled the vortex” – they didn’t control the vortex from Philadelphia – “Philadelphia was just another power source, that’s all it was.”

AB: “What did you actually do [at Montauk]? What did you work on?”

PN: “I was the fellow who set up the pulse modulation schemes ... and set up the frequency hopping.”

AB: “What did they tell you you were working on?”

PN: “They told me that we were working on equipment to interface human beings to technology – the mind of man to technology.”

AB: “It seems to me that’s a very, very dangerous technology. Very dangerous.”

PN: "It's very dangerous, yes, I agree with you. That's why we all decided at the end of the [Montauk] project to crash it."

AB: "Oh, you did?"

PN: "That's why the monster was created – to crash the project. ... Because Duncan especially was saying things that the rest of us didn't dare say. ... Duncan ... called a meeting," and we all agreed the project was getting out of hand, "and getting very evil ... We all knew this, but we didn't have the guts to say it."

To bring the thing down, they agreed to create a monster which would convince the powers that be to end the project.

AB: "Fascinating ... and it worked?"

PN: "Yes, it worked very well."

PN: PN has a book titled *Montauk Revisited*.

Aud: Is the Montauk Project related to the Amityville Horror?

PN: "I don't know. I was involved years ago as a parapsychology researcher," and PN was at the Amityville Horror house – "We really couldn't tie much of anything to that house. That's all I'll say on it."

AB: "Very briefly, let's take a sidetrack, 'cause that's fascinating – what did you find at Amityville?"

PN: At Amityville, "we checked the heat differential, we checked the static charges, we checked ... for magnetic anomalies – we didn't find anything – no bugs, no bleeding wall ... there were even rumors of an Indian burial ground under the house ... who knows?"

Amityville may have been a genuine haunting, but PN believes it was blown out of proportion.

Aud: Was the supercollider [eventually planned to encircle Waxahachie, TX] in any way connected to Montauk?

PN: "No, the supercollider came afterwards."

PN: Claims “physicists have reached the speed of light with particles.” Also claims there was some source of radiation at Montauk, ‘because I suffered from radiation sickness for awhile.”

\* \* \*

AB: “They have considered using controlled nuclear explosions in satellites to focus beams ....”

PN: (interrupting) “Yeah, to focus a laser ... I’ve read the same thing. But you really don’t need that ....” Not if you use a particle accelerator.

\* \* \*

PN: “Magical things happen when you reach the speed of light.”

AB: “What about surpassing it – is it possible?”

PN: “Not in this dimension. ... You cannot surpass the speed of light within our reference frame.”

“I believe it is possible to go past [the speed of light], but not in our reality as we know it. You got to warp into another reality ....”

Aud: Is there any way to render oneself impervious to mind control?

PN: Yes. “You’ve just got to raise your level of conscious awareness above that.” ...

“That’s part of the reason why I’m putting this information out” – so people can protect themselves on a subconscious level.

AB: So people can protect themselves with their own free will?

PN: Yes. “This is a message of the New Age essentially.”

AB: “So the New Age is mixed in with all of this?”

PN: “Oh yes, very definitely. **This is the application of New Age metaphysical principles to technology.**

AB: What happens if one of these particle accelerators ‘goes south’ [melts down]?

PN: I’m not a nuclear physicist [so] I don’t know ... a Black Hole? A burst of neutron radiation?

PN: The whole mind control aspect of the [Montauk Project] is evil – man is meant to have a free mind – not to be dominated.

AB: Once they've experimented and achieved mind control, "how are you ever going to stop them?"

PN: We have to get the "population aware enough, so that it just doesn't work."

Aud: Can the minds of people be altered in terms of how they vote [in elections]?

PN: "They could be."

AB: "It certainly is possible, correct?"

PN: "Oh sure, it's possible – and what he's saying might be correct."

Aud: Caller brings up Einstein's scenario of going back in time and killing your ancestor to prevent yourself from being born – doesn't that make Time Travel in terms of going back in history impossible?

PN: "Not impossible, it's just you become part of history – and you really can't affect history, because you become part of it."

PN: "To some people, what you think up in your mind is a parallel reality."

Will not say that 'age regression' is impossible – has to deal with our DNA. Theoretically we could energetically replicate DNA.

AB: "If it's possible to travel in time, and I went back to say 1950, my chronological age at the end of the travel [back in time] would still be what it is just roughly, at the moment I left, wouldn't it?"

PN: "Yes, exactly."

PN: Has heard of the 'Order of the Twelve (12)', but has not heard of the 'Nine (9) Rulers of the White Lodge.'

AB: "I learned long ago not to stick up my nose at what *appears* to be fantastic, because I've been surprised too many times."

And I'm sure of this: "The 'powers that be' would have great interest in mind control, and if they're *not* working at mind control, I think that would be more fantastic than believing that they are working on it."

PN: "Right."

AB: "I mean, it's that simple."

PN: Believes mind control works, but I'm "just not sure exactly how well the time tunnel worked." ... "They could not at that time work on mass populations using the particle beam system that interacts with the brain directly – you don't need a 'signature' anymore ...."

AB: "So you're saying that mass mind control is not necessarily possible?"

PN: "Today it is."

AB: "So you're saying they could be sending out signals that are actually controlling the masses?"

PN: "Um-hmm. Synapses."

AB: "Wow! Wonderful!"

Aud: "Could this be described as hell" what you're talking about?

PN: "Hell is whatever you make it."

Aud: "Have you ever seen any alien beings?"

PN: "Yes, I have seen some alien beings."

AB: "You have?"

PN: "Who or what they are beats the hell out of me!"

AB: "What have you seen exactly – how and where?"

PN: "At Montauk, they had a little creature" that looked like a gray as described by Whitley Strieber – four (4) feet tall and stunk to high heaven. They also had a half-human, half-lizard type creature. "What it was I really don't know."

Sort of looked like the Gorn on an old Star Trek episode ....

AB: "Some of this, you've gotta admit, Preston – it's wild stuff!"

PN: "I know it's wild stuff. This is why I doubted my own sanity at times ... myself."

AB: "How many other people have corroborated what you're saying, or substantial parts of what you're saying?"

PN: "Oh, about 30-odd people."

PN: Believes the weather is being manipulated for warfare aka 'weather war.' Not sure who is responsible.

Aud: Who is tracking the money?

PN: I was told they could not trace any monies for the Montauk Project. ...  
"Montauk was a hidden project. There's rumors that the Montauk Project was financed by gold smuggled from the Nazis – we really don't know. ... This is something that Al Bielek has suggested."

AB: "There are a lot of people listening [who] would say you're crazy as a loon." How would you respond to them?

PN: "We have a lot of witnesses, [but] no real world documentation evidence as proof."
